Corrigendum

The 29th October, 2020

No. GSR 40504.—The matter with regards to introduction of "Time Bound Designation (up-gradation) Scheme" in the Government Medical College & Hospital, Sector-32, Chandigarh was engaging the attention of the Government for some time.

Now, the Administrator, UT, Chandigarh, is pleased to frame "Time Bound Designation (up-gradation) Scheme" for the faculty members of Government Medical College and Hospital, U.T, Chandigarh, as under :—

1. **Short title & Commencement**—This Scheme shall be called Govt. Medical College & Hospital, Sector-32, Chandigarh "Time Bound Designation (up-gradation) Scheme, 2020".

It shall come into force from the date of its publication in the gazette.

2. Designation under "Time Bound Designation Scheme"- All the faculty members of the Department of Medical Education and Research, Chandigarh Administration shall be granted designation to the next higher posts subject to fulfillment of eligibility criterion as prescribed in the notified Recruitment Rules for the next higher post under the "Time Bound designation (up-gradation) Scheme" herein after referred to as the TBDS, as under :—

1. An Assistant Professor shall be eligible for designation as an Associate Professor after 05 years of regular service as Assistant Professor.
2. An Associate Professor shall be eligible for designation as Professor after 04 years of regular service through UPSC or designated Associate Professor under TBDS. The designated Associate Professors under TBDS would be considered for designation as Professor only after the regular Associate Professor through UPSC is designated as Professor under TBDS in the same Department.
3. For the purpose of this scheme, regular service means service by a Government servant on the appointment by the UPSC or promotion after regular selection through UPSC/ DPC or designated under TBDS.
4. The designation under TBDS shall be upgraded without any linkage to vacancies & pay scales, etc.

5. The designation of the next higher post under TBDS will be considered for further promotion/ appointment but not confer any right for seniority etc.
6. No financial benefit will be allowed under the TBDS and the eligible Assistant Professor/ Associate Professor will be designated to next higher post upon fulfilment of eligibility criterion.
7. Service rendered outside the college on non-academic positions/ deputation will not be taken into consideration while giving designation under this Scheme. However, the service rendered outside will be counted on notional basis, i.e. his/ her original designation at GMCH, Chandigarh, at par with his counterparts for all intent and purposes of giving designation under TBDS.
8. Any incumbent, who gets higher designation under this scheme will also be entitled for further designation to next higher post on gaining eligibility only after putting in the required years of qualifying service at the lower post. Example :—An Assistant Professor who might have put on 06 years service as Assistant Professor, would be eligible for the designation of Associate Professor retrospectively on attaining 05 years services and remaining period of 01 years would be considered for next designation. Thus, after 03 years, he would be entitled for the next designation as Professor.
9. The proposed TBDS, once implemented, will replace the existing Carrier Advancement (Re-designation) Scheme (CAS) notified in the Gazette dated 01.03.2007. However the faculty who have already got the benefit of re-designation under existing CAS will be considered for further designation from the present re-designated post.
