Public Auction Notice


An open auction of the unserviceable condemned torn linen shall be held on **28.01.2021 at 11:00 A.M** in GMCH-32, Chandigarh.


All the participants, who wish to participate in the auction will be required to deposit an amount of Rs. 5,000/- (Rupees Five Thousand Only) in cash as security deposit before the start of the auction which will be refundable to the unsuccessful bidder after the bid is over.


The terms and conditions of e-Auction and for lifting of the condemned linen items are as under:-


1. The goods will be sold to the highest bidder on "AS IS WHERE IS BASIS"
2. The rates for condemned linen items will be in Indian Rupees per kilogram.
3. The successful bidder shall bear all expenses such as carriage charges, loading-unloading and *transportation* shifting charges etc and lift the condemned linen items within 7 days from the issue of sale order.
4. The successful bidder will be required to deposit 50% of the total tentative sale value within 24 hours after the issue of sale order along with Taxes and balance 50% will have to deposit immediately after actual weight of materials/items done.
5. TCS & GST will be charged extra as applicable.
6. The weight of the condemned linen items will be done in the presence of rep. of Govt. Medical College Hospital, Sector 32, Chandigarh on the weighing machine installed in the Institute or from Electronic Public Weigh Bridge, Chandigarh Industrial & Tourism Dev. Corp. Ltd (CITCO), 181/1-2, Industrial Area, Phase-1, Chandigarh. The charges, such as carriage charges, weighing charges, loading/unloading charges shall be borne by the successful bidder.
7. In case the selected bidder does not show interest in depositing the balance sale value or in lifting the material, within stipulated period (7 days), the entire amount including EMD shall be forfeited and other actions initiated including resale of the goods in question at the risk and cost of the defaulter.
8. The items shall remain, in every aspect, at the risk of the buyer from the time of acceptance of his offer. The seller will not undertake any liability whatsoever for the safe custody, protection or preservation after the sale has been confirmed.
9. In the event of highest bidder fails to lift the materials the second highest bidder & thereafter third bidder will be considered to lift the material at the rate given by the highest bidder (First).
10. The EMD of the unsuccessful bidders will be returned after finalization of the Open Auction process.
11. The decision of the Director Principal of GMCH will be final and the Director Principal GMCH reserves the right to accept/reject any bid (including highest bid) without assigning any reason thereof.
12. The GMCH may impose/relax any condition and announce the same at the time of auction.
13. The decision of the GMCH Authorities will be final.
14. All disputes will be subject to Chandigarh jurisdictions.




