In exercise of powers conferred by Rule 22 of the Government Residences (Government Medical College/Hospital, Chandigarh Pool) Allotment Rules, 1996, the Director Principal, Government Medical College & Hospital, U.T., Chandigarh hereby makes the following rules further to amend the Government Residences (Government Medical College & Hospital, Chandigarh Pool) Allotment Rules, 1996 namely:-

1. (i) These Rules may be called the Government Residences (Government Medical College & Hospital, Chandigarh Pool) Allotment (9th Amendment) Rules, 2010.
- (ii) These shall come into force with immediate effect.
2. In the Government Residences (Government Medical College/Hospital, Chandigarh Pool) Allotment Rules, 1996 for Annexure-1, subsequently amended, vide Notification No. Estate/1/(203)/2008/42554, dated 01st October, 2008, the following shall be substituted namely:-

ANNEXURE-1

1. In the said rules of 1996, in Rule 2(n), the following proviso shall be added at the end under -

Provided that past service rendered by the officer/official in Defence/Armed Forces shall be counted for the purpose of determination of entitlement of accommodation for allotment of GMCH Pool Houses by way of fixation of "Notional pay" of 10% Servicemen. The notional pay shall be determined by the concerned Establishment Branch.
2. In the said rules of 1996, in Rule 12(2) the following table is inserted:-


TABLE

Events	Permissible period for the residence
(i) Retirement/pre-mature retirement, Terminal leave, Repatriation from Government Medical College, Resignation, Dismissal or Removal from service, termination of services or unauthorized absence without permission of Regular/Permanent employee.	Four months
(ii) Temporary transfer in or outside India	Six Months
(iii) Leave (other than leave preparatory to retirement, refused leave, terminal leave)	For the entire period of leave
(iv) Leave preparatory to retirement or refused leave granted as per rules applicable	For the full period of leave or the average pay subject to a maximum of six months inclusive of the period permissible in the case of retirement
(v) Deputation outside India	One Year
(vi) On proceeding on training	For full period of training
(vii) Death of the allottee	One year

3. In the said rules of 1996, in Rule 12 (b) of the amendment notification circulated under No. GMCH/Estate/I(203)/2008/42553 dated 01.10.2008, the following shall be substituted under -

The Word "Substituted" is replaced with "Inserted"
4. In the said rules of 1996, in the last para of Rule 16 (3) the proviso, at the end, shall be substituted as under:-

Provided that no exchange of houses on mutual consent shall be allowed.
