

**PROCEEDINGS OF THE MEETING HELD ON 06.03.2024 UNDER THE CHAIRMANSHIP OF PROF. DASARI HARISH, HOD, DEPTT. OF FORENSIC MEDICINE FOR FRAMING THE RECRUITMENT RULES OF THE POSTS OF TUTOR, LECTURER, READER/ASSOCIATE PROFESSOR, PROFESSOR-CUM-VICE PRINCIPAL, PROFESSOR-CUM-PRINCIPAL, ADMINISTRATIVE OFFICER.**
