ORDER

TERM & CONDITIONS FOR INTERNSHIP TO EXTERNAL INTERNS-MBBS

Internship applications from those External Interns who have passed MBBS are entertained by Academic Section of the College on first come first basis with a maximum intake of 40 Intern at any given time. No stipend is paid to such Interns but they are required to pay Rs. 20,000/- per annum to the College for availing clinical & infrastructural facilities for this training. The candidates are required to produce following documents: -

1. You will have to deposit a sum of Rs.20,000/- (Rs. Twenty thousand only) per annum as one-time training fee or Rs.5500/- (Rs. five thousand five hundred only) on quarterly basis which is n refundable.
2. That no stipend will be paid during the internship period.
3. Duly attested photocopy of certificate having passed the Final Prof. MBBS examination. Original to be seen at the time of joining internship.
4. Duly attested photocopy of documentary proof to the effect that the parent institute duly stands recognized by the Medical Council of India. Original to be seen at the time of joining internship.
5. Schedule of internship applicable at parent institute & existing rules regarding postings in Community Medicine.
6. The draft duty roster is submitted as per schedule/requirement of parent institute. The final duty roster will not be changed at the later stage once the competent authority approves it.
7. Duly attested photocopy of No Objection Certificate for doing internship form parent institute original to be seen at the time of joining internship.
8. Duly attested photocopy of Character certificate from parent institute. Original to be seen at the time of joining internship.
9. Two recent passport size photographs and photocopy of passport (in case of foreign students).
10. Duly attested photocopy of Provisional Registration certificate of Medical Council of India/State Medical Council. Original to be seen at the time of joining internship.
11. That you can put on duty anywhere in Union Territory (U.T.), Chandigarh in public interest as and when required by the Administration and wear the white Doctor's Coat when on duty.
12. That you will adhere to the rules and Regulations of this Hospital and any contravention of the same will result in termination of your training. You will behave in decent manner with the patients, hospital staff and doctors under whom you will place for internship training.
13. Candidate should be fully immunized including Hepatitis-B. This hospital will not bear any cost of their immunization.
14. In case, you leave the Hospital or competent authority cancel your internship training money deposited with this office will be forfeited.
15. That the permission of training is liable to be withdrawn to any time without assigning any reason. This offer as a favour and it may withdraw at any time.
16. The Application should be submitted by candidate in original alongwith proforma.
17. That the application should be routed through competent authority i.e. Director Principal/Principal/Dean of the Parent Institute with attested copies of Provisional passing/DMCs of MBBS course.
