ORDER

WHEREAS, the supply order for the purchase of 02 Nos. Ambulatory Blood Pressure Monitor Model BTL-08 ABPM for the department of General Medicine was issued in favour of M/s Harmed Technologies, SCO 324-325, 1st Floor, Sector 38-D, Chandigarh vide this office Memo No. **GMCH/PB-II/III/10/9078** dated **21-06-2010**. Accordingly, the said firm has supplied the said equipment and installed in the Department of General Medicine, GMCH-32, Chandigarh on 06-10-2010.

AND WHEREAS, As per the supply order the firm was required to enter into CAMC agreement on or before 03 months of the expiry of warranty period.

AND WHEREAS, after warranty period of Two(02) years, the said firm was requested vide letter no. 11787-89 dated 17-07-2012 to submit CAMC agreement for the period of Five(05) years as per the rates already approved in the supply order dated 21-06-2010.

AND WHEREAS, despite of several communications, the said firm has not took sincere efforts and failed to entered into CAMC Agreement in this regard. Thereafter last opportunity was also offered to the firm vide letter no. 27931 dated 05-09-2017, again M/s Harmed Technologies, Chandigarh do not pay any heed to it. The action of the firm has caused mental, physical harassment and financial loss to the Govt. Exchequer as well as affect the functioning of the Hospital in the interest of the patient care services.

NOW THEREFORE, after careful consideration and the facts highlighted above, the undersigned being competent authority has come to the conclusion that the firm M/s Harmed Technologies, SCO 324-325, 1st Floor, Sector 38-D, Chandigarh **is hereby debarred** from the Chandigarh Administration with immediate effect for future participation in any kind of Contract/ Tender/ EOI/ Quotation etc. for a period of One year.


