The Government of Punjab as per their letter No. 18/4/2010-4FP2/225, dated 21.5.2010 (copy enclosed) have enhanced the rates of Washing Allowance from Rs.30.00 per month to Rs.60.00 per month for Class IV employees and Drivers of Motor Vehicles (other than commercial vehicles of Punjab Roadways) of State Government and Gate Keepers and Gate Messengers of Punjab Civil Secretariat with effect from 1.5.2010. 2. The expenditure involved, if any should be met from within the sanctioned budget grant and no additional funds will be provided for this purpose.
