Sir/Madam,

I am directed to address you on the subject noted above and to state that it has been observed that many of the departments in the U.T. Chandigarh stress upon the submission of affidavit from the general public, which not only costs money but also involves wastage of time. The matter has been reconsidered by the Administration and it is felt that there is need to bring simplification of procedures to the center-stage of governance reforms. Leaving aside specific requirements, the broad principles of such reforms must be simplification of government procedures so as to have citizen centric governance. The citizenfriendly provision of self-certification would be well received as it would save time, effort and money. In order to simplify the procedure and to dispense with the system of submitting affidavits duly attested, the departments are required to undertake a comprehensive exercise, for identifying all the services under their control in which affidavits or signatures of gazetted officers are required. In order to phase out the existing formalities and to replace then by self certification, you are requested to supply the information in the format for taking a policy decision as under:-
