

Subject: Grant of Interim Relief to Group 'C' and Group 'D' Employees of Haryana Government.

Sir/Madam,

I am directed to address you on the above subject and to say that the Government of Haryana has decided to grant Interim Relief to all Group-'C' and Group 'D' employees of Haryana Government @ 2000/- per month w.e.f. 01.01.2014, subject to the following conditions:-

- (i) The Interim Relief @ 2000/- per month will be admissible only to Group- 'C' and Group 'D' employees working on regular basis, w.e.f. 1.1.2014 in various Department of the Government. It will be paid for the salary of the month of January, 2014 in the month of February, 2014.
- (ii) This Interim Relief will be dis-continued from the date of implementation of the recommendations of 7th Central pay Commission.
- (iii) The amount of Interim Relief will be sui generic viz. it will neither be termed as "Pay" nor "Allowance" nor "Wage". Accordingly, this amount will not count for any service benefits i.e. Computation of House Rent Allowance, Hill Compensatory Allowance, Overtime Allowance, Cash Compensation, Encashment of leave, Pay Fixation, Dearness Allowance, Pension or Gratuity etc.
- (iv) The employee will cease to draw the Interim Relief on his/her appointment/ promotion to any post of Group A or B categories.
