In supersession of the order bearing Endst. 2. That the officer is entitled to pay equal to the pay last drawn by him on the date on which he attains the age of 58 years and the officer shall be entitled to the allowances applicable to him from time to time as per the rules.
3. That this order shall be applicable upto 31.12.2015 which has been computed from the date of superannuation or till the final decision in this regard is taken by the Chandigarh Administration or whichever is earlier.
4. That the officer shall not be entitled for any pensionary benefits during the said extension period.
