Chandigarh is pleased to launch the following scheme:-

- This scheme is open for the children of Safai Karamcharis employed in the Office/Board/ Corporation of Chandigarh Administration/Other Governments/Private Sectors on regular/on temporary/on adhoc/on daily wages/on D.C. rates/ on out sourced or through contractor or private Safai Karamchari. Safai Karamchari means a person engaged in sanitation related work including sewerman or helper assisting in the sanitation/sewerage work.
- Applications under the scheme are invited by the Corporation on the following 2. eligibility criteria:-

## ELIGIBILITY CRITERIA:

Applicants/Students fulfilling the following criteria, shall be eligible for benefit under the scheme:-

- The parents of the applicant should belong to Scheduled Caste category and i) should be residing in Chandigarh for the last 3 years.
- Either or both parents of the applicant should be an employee of the ii) Administration/Other Department/Board/Corporation of Chandigarh Governments/Private Sectors on regular/on temporary/on adhoc/on daily wages/on D.C. rates/ on out sourced or through contractor or private Safai Karamcharies.
- The total annual family income of parents shall not exceed Rs.2,50,000/-. iii)
- The applicant should have passed 10th or 12th class in first attempt from any iv) school located in Chandigarh having 60% marks or above.
- v) The applicant must have taken admission into the higher class/course in any of the Govt. / Govt. aided /Professional Educational Institutions/Colleges/ Schools.
- vi) Application for the benefit under the scheme must be supported by requisite documentary proof such as the employer certificate from the Department where his/her parents are employed to the effect that his/her parents is/are Safai the Office/Board/Corporation of the Chandigarh Karamchari in Administration/Other Governments/Private Sectors at least for the last one year, the copy of 10th or 12th pass certificate, copy of birth certificate etc. The authenticity of the employer certificate is subject to verification by Social Welfare Department from the concerned issuing authority.
- vii) In case Private Safai Karamcharis a certificate should be issued by the Committee consisting of concerned Sub Divisional Officer (Civil) and Director Social Welfare, Chandigarh Administration.
- viii) Selection of beneficiaries under the scheme shall be done by a Committee headed by the Secretary Social Welfare, Union Territory, Chandigarh with Director Social Welfare, Union Territory, Chandigarh and Director Higher Education, U.T., Chandigarh or his representative and District Education Officer or his representative as its members.

#### PROCEDURE FOR APPLYING:

The applicant should apply in the prescribed format alongwith the required documents within four months from the date of result duly recommended by the Head of Educational Institution where he/she has taken admission.

#### MODE OF PAYMENT:

The award will be given to the eligible students/applicants on the basis of performance of 10th or 12th class as under:-

1	From 60% to 70%	Rs. 15,000/-
1.	Above 70% to 80%	Rs. 20,000/-
