Minutes of the meeting taken by JS(UT) on 1st March, 2013 regarding review of vacancy positions in the Union Territories (without Legislature)

An Inter-Ministerial meeting was convened under the Chairmanship of Joint Secretary (UT) on 1st March, 2013 at 3.30 P.M. in the Ministry of Home Affairs, North Block, New Delhi to review the pending vacancy positions in the various Departments of the Union Territories of Andaman and Nicobar Islands, Lakshadweep, Daman and Diu, Dadra and Nagar Haveli and Chandigarh, which are pending with Central Ministries/Departments.

After welcoming the participants, the Chairman stated that the proposals for filling up the vacancies/RRs of the UTs are pending in different Ministries/Departments of the Central Government and the UPSC and, hence, this meeting has been convened to resolve the pending issues with the concerned Ministries/Departments. Thereafter, he asked the representative of Chandigarh to apprise the meeting about the pending proposal in the Central Ministries.

The representative of Chandigarh stated that, as per the RTE Act, new schools have been set up with UT Administration would submit its proposal for framing Recruitment Rules of teachers as well as teachers of technical education for diploma holders. He also stated that a proposal for filling up of 36 posts were sent to HRD which were still pending in that Ministry. The representative of HRD informed that since the proposals were incomplete, they returned the same to the UT concerned on 27.2.2012 for clarification.

Regarding the issues pending with Health Ministry, the representative of Chandigarh Administration stated that he was getting necessary help from that Ministry and there is no pending issue.

The representative of Chandigarh Administration stated that proposal for RRs regarding the Court Master was pending in Labour Ministry. However, representative of M/o Labour stated that no proposal was received from the UT Administration. Chairman asked UT Admn. to send their proposals to M/o Labour.

The representative of Chandigarh stated that their proposal for RRs are pending in UPSC and MoUD. However, the representative of MoUD stated that he is from the D/o Printing and that he would ask the concerned officer in the in the Works Division to attend to this work immediately.

Thereafter, the representative of DNH and DDU stated that UTs' proposals relating to Daman and Diu Health Services Rules are required to be framed and the UPSC had raised some queries which will be replied shortly. He informed that M/o Health has requested MHA to provide copy of the notification. The said notification pertains to 1965. The Chairman has directed officials of the UT Division to locate the said notification from the old records of MHA/MEA. The representative of DNH has also stated that the issue that RR for senior specialist are pending with UPSC and the UT officials have already discussed with the officials of UPSC to resolve the issue. However, not much headway has been made and, therefore, requested MHA's intervention in the matter. The deputation of specialists to the UTs was also discussed. However, the representative of M/o Health stated that this issue is being looked after by

Medical Education Wing of MoHFW and he will pass on the instructions to the concerned officer. He also stated that RR for Nursing are pending in nursing section since no body from the nursing side had attended the meeting. JS (UT) directed that CPD desk should put up a D.O. letter from him to Shri Vishwas Mehta, JS, MoHFW may be sent. The Chairman also stated that under the NRHM Scheme, proposals for creation of posts need not be sent to M/o Finance for its approval. The representative of Daman and Diu also stated that one proposal for RR was cleared by UPSC and the same is being notified. The representative of M/oHRD stated that the UPSC cleared the proposal in July, 2012 and that he had just processed the same in the file. However, as per the UPSC guidelines, the notifications had to be done within seven weeks and in this case, the time has exceeded and he would seek the advice of the Commission. The Chairman stated that since the UPSC had already cleared, the proposal need not be sent to the Commission for the sake of delays and that needed to be cleared internally. M/o HRD's representative stated that the proposal regarding RRs pertaining to Government Polytechnic was sent to D/O Higher Education on 11th March, 2012 which had been referred back to the UT for some clarification which is awaited from the UT. The Chairman stated that during his next visit the representative of UT may bring a suitable reply. With regards to RRs pending with Urban Development their representative informed that the matter pertains to CPWD(Works Division) whereas he was from Directorate of Printing.

The representative of Lakshadweep stated that a proposal for the post of Manager (Printing) was pending since 28.4.2012 with MoUD. The representative of D/o Printing replied that the UT Administration had not sent

Annexure-2 and in Annexure - 3, they had given certain observations and sent to the UT on 9.5.12, which has not been received back in their Ministry.

The Chairman apprised the Air connectivity will be restored by Air India from 2.3.2013. He asked the officials of MHA that UT Administration may be asked to arrange a Helicopter for doctors from Kochi to Lakshadweep during their deputation. He also requested that the team replacing team of doctors posted on 90 days rotational basis, should be asked to join one week before the tenure of the old team is going to expire to maintain connectivity.

The chairman directed that the DRCs of the UTs should visit the Ministries on weekly basis and interact with the Concerned Ministries so as to facilitate/expedite cases.

The representative of Lakshadweep also stated that there is creation two posts of Chief Engineer are pending with MoUD. However, MoUD this matter pertains to the Works Division of MoUD and he would request that Division to look into this issue for the needful. The Chairman suggested that a suitable communication may be sent to the Works Division of MoUD.

CS, A&N Islands stated that that there is acute shortage of Specialists Doctors in the Islands. He requested that instead of posting for 90 days specialists should be posted for 180 days so that the health care system can be run smoothly. It was informed that this issue may be brought to the notice of Division concerned. The Chairman apprised the meeting that a meeting of HMAAC was held on 20.2.13 in the Chairmanship of HM in which Secretary Health also attended the meeting and the issues relating to the UT were discussed. CS, ANI. The Chairman, MHA informed that on the rotational basis posting, it should be kept in view that there is a need of posting of integrated

team of doctors comprising Surgeon and Anesthetist as in the absence of Anesthetist, Surgeon cannot function and purpose of posting will be defeated.

M/o Health had raised the issue of transportation in Lakshadweep as most of the Doctors are from CGHS and they find difficult to reach there. The chairman replied that the air services are being resorted. He has directed that integrated team of doctors to be sent to Lakshadweep and the next team should be reached their one week before the completion of their tenure and transportation/helicopter will be provided by the Administration.

The representative of M/o Shipping informed that the Ministry has sought certain details from the UT Administration in connection with the audit paras as well as the VIP references pending in that Ministry. He also stated that the Ministries considering the proposal from the UT Administration for Port Officer which is pending since 1998. Chairman stated that for time being the post is being managed by the DANICS officers and he stated that being a technical post M/o Shipping should finalize the process for RR so that the post is filled up immediately.

It was brought to the notice of the Chairman that 27 posts of HRD Ministry are pending. The representative of HRD Ministry informed that the matter is related to Higher Educational. It was suggested that HRD may forward the papers to Higher Education. Chairman asked M/o Shipping to expedite the matter of filling up 16 vacancies. D/o Agriculture informed that as far as they are concerned, there is no pending issue with ANI. The representative of D/o Animal Husbandary and Fishing said that UPSC has already notified on 13th February, 2013 2 posts of Joint Director. The

representative of ANI informed that there was shortage of Labour Welfare Officers in the UT Administration to which the representative of M/o Labour stated that there has been shortfall of about 57 officers throughout the country and UPSC has already advertised for 57 posts and it will take further 5-6 months for process to fill the posts. The Chairman suggested that in the interim and alternative arrangement may be made so that an officer may be posted in the UT which has sizable industries about 20,000 private companies involved in shipping and boarding generation and tourism etc. and workers are not paid.

The representative of M/o Labour also stated that in the last meeting it was suggested that posting of an officer was urgent and, accordingly he moved the file to the Transfer Committee, however, the Committee could not find a suitable officer. The Chairman directed that a proposal from the UT Division may go to M/o Labour for posting of a Labour Welfare Officer on transfer till such time the recruitment is finalised by the UPSC. It was also informed in the meeting that the proposal of Lakshadweep Administration regarding the RR was not received. However, the representative of Lakshadweep handed over the copy of the C/o Fisheries. The representative of D/o Animal Husbandary has also stated that post carrying a grade pay of Rs. 6600 and below need not be sent to the Ministry/UPSC, as it is exempted. The Chairman directed the concerned Ministry to send proof to this effect in writing. He simultaneously directed that said notification exempting the above may be obtained from DoPT/UPSC.

The meeting ended with a vote of thanks to the Chair.
