- i) Recommendations/nominations in respect of the Govt. officials may be sent only by the Head of Departments, after personal scrutiny of the cases in prescribed proforma :-

- ii) In case of Govt. officers/officials, those who have been awarded any punishment in departmental proceedings or convicted in any criminal case or to whom a charge-sheet has been served in departmental proceedings or against whom a criminal case has been registered, will not be eligible for award of the Commendation Certificate.
- iii) A maximum of two persons may be recommended by the Head of Department in respect of the officials of his department.
- iv) In case of non-officials, the recommendations may be supported by attested copies of documents.

Recommendations/nominations, with brief citations (not more than one page) in respect of persons, may be sent to Home Department (In Home-I Branch), Chandigarh Administration Secretariat through the concerned Administrative Secretary on or before 20.7.2015.

It may be added that before sending recommendations/ nominations of the officials, the entire record should be scrutinized and integrity certificate based on ACRs and other record must invariably be accompanied with each recommendation. It may please be noted that no recommendation will be entertained after the stipulated date.
