

Dear Secretary,

It has been observed that some Ministries/Departments are nominating Members of Parliament for delegations abroad sponsored by them and thereafter seeking approval of the Ministry of Parliamentary Affairs for these nominations.

2. In this connection, I would like to draw your attention to Para 4(i) of Cabinet Secretariat O.M.No.21/1/7/94-Cab. dated 30th March, 1995 (detailed guidelines may be seen at <http://cabsec.nic.in/files/circulars/foreigntravel/NOTICE1.pdf>). As may be seen therefrom selection of Members of Parliament for Government sponsored delegations comes within the functions of the Minister of Parliamentary Affairs. Administrative Ministry/Department should not propose the name of any Member of Parliament for inclusion in such delegations as the selection is to be made by Hon'ble Minister of Parliamentary Affairs in consultation with Minister incharge of the Administrative Ministry and the Ministry of External Affairs, with the approval of the Prime Minister.

3. A database of Members of Parliament going in different delegations is maintained in this Ministry for ensuring fair representation/chance to the members.

4. May I therefore request you to kindly issue necessary instructions to the concerned officers in your Ministry to keep the above guidelines in view while processing such proposals in future.
