Minutes of the 17th Meeting of the Standing Committee of Northern Zonal Council held on 26th May, 2016 at Srinagar, Jammu & Kashmir

The 17th meeting of the Standing Committee of Northern Zonal Council was held at Srinagar on 26th May, 2016 under the Chairmanship of Chief Secretary, Government of J&K. List of the participants is attached as **Annexure**.

Agenda No.1- Action Taken Report on the recommendations of the 27th Meeting of the Northern Zonal Council held on 25th April 2015:

1.1 Need for fiscal and infrastructural harmony in Northern States.
(Sponsored by Government of Himachal Pradesh)

It was informed by the ISCS that the Empowered Committee of Finance Ministers of Northern States under the Chairmanship of Finance Minister of Govt. of Rajasthan and then again under Finance Minister, Govt. of Himachal Pradesh which was constituted earlier for examining this issue and making recommendations could not meet, so the same be now chaired by Finance Minister Govt. of J&K.

In response, the Chief Secretary, Govt. of J&K informed that Finance Minister, Govt. of J&K has agreed to chair this Committee and issues such as harmonization of tax regimes, power trading arrangement, sharing of resources etc. will be discussed in the meeting. Other States will also be requested to suggest items that need to be considered by this Committee. A meeting will be fixed after ascertaining the convenience of Finance Ministers of other Northern States.

Decision: Finance Minister, Govt. of J&K will chair the Committee.
(Action: Govt. of J&K)

1.2 Joint efforts for export of fruits, flowers and vegetables from the States.

(Sponsored by Govt. of Himachal Pradesh)

Representative of APEDA informed that they have funded several projects in Himachal Pradesh but proposal from the Government of Punjab for perishable cargo centre at Amritsar airport earlier requested by them is yet to be received. No officer from Govt. of Punjab attended the meeting to comment. **Representative of Government of J&K** requested the Govt. of NCT of Delhi to provide some premises in Delhi for marketing their



agri products in the Capital. Chief Secretary, Govt. of NCT of Delhi stated that even though it is difficult to provide space in Delhi, however, the matter will be reconsidered. **Representative of Government of J&K** also requested APEDA to help them to develop markets for walnut, apples etc. specially to promote their Saffron Mission. **APEDA** informed that they have received some proposals from Govt. of J&K which are currently under examination. Regarding Saffron Mission, the Committee advised the Govt. of J&K to send a formal proposal, which the State Govt. agreed to do. Govt. of Haryana requested for logistic support for development of Special Agri Processing Zone in Gannaur, situated at Delhi-Haryana border along the National Highway. Representative of Ministry of Agriculture stated that promotion of agro-produce was discussed in the National Horticulture Mission to promote agri business in the North and the matter is under consideration and logistic support for Gannaur is also under consideration.

Decision: The Standing Committee decided to retain the item as several States are involved with specific requests therein. It was also decided that J&K will be in touch with APEDA for promotion of their Saffron Mission.
(Action: APEDA, Govts. of J&K, NCT of Delhi and Punjab)

1.3 Sharing of Water and Power.

(a) Share of Power for UT of Chandigarh from Kishau & Renuka Dams, Hathnikund Barrage and BBMB.

(Sponsored by UT of Chandigarh)

(b) Finalisation of the claim of Haryana and Rajasthan for share of power from hydel projects of Anandpur sahib, Shahpur Kandi, Mukerian, UBDC Stage-II, Thein Dam and SYL Projects.

(Sponsored by Government of Haryana)

UT of Chandigarh informed that the power issue is yet to be resolved in respect of UT of Chandigarh, although water issue has been resolved. Representative of **Government of Rajasthan** stated that they also have a claim on power to be generated from these projects but water is no longer an issue. **Govt. of Haryana** said that the issue in item (a) is linked with item (b). If they get power from hydel projects given under (b), they will have no issue with Kishau/Renuka power projects. **Chief Secretary, Government of NCT of Delhi** informed that Yamuna Water Agreement of 1994 was not signed by Govt. of Rajasthan, thus, when new agreement is signed, supply of water from Renuka dam to Delhi, which is for only drinking purpose may be ensured therein.

Decision: It was understood that item (b) is subjudice and intricately linked with (a), so these may be clubbed together for next Zonal Council meeting. Also, Ministry of Water Resources, River Development and Ganga Rejuvenation would send current status of new agreement to the ISCS within 1 week. Items retained.

- (c) **Sharing of Inter-State River water issues.**

(Sponsored by Government of Rajasthan)

- (i) **Restoration of remaining 0.60 MAF Ravi-Beas Waters by Punjab to Rajasthan**

Since the matter was subjudice and the representative of Govt. of Punjab did not attend the meeting, the item could not be discussed.

Decision: Item retained for next Zonal Council meeting.

- (ii) **Supply of Yamuna Water to Rajasthan at Tajewala.**

Chief Secretary, Govt. of Haryana informed that a meeting between the Chief Ministers of Govt. of Rajasthan and Haryana would be chaired by the Minister of Water Resources, soon to arrive at a solution.

Decision: In view of the above the item was retained.

- (iii) **Allocation of 0.17 MAF Ravi-Beas water (Ex. Nangal) to Rajasthan through Bhakra Main Line.**

- (iv) **Transfer of control of Headworks at Ropar, Harike and Ferozpur**

It was understood that these matters were subjudice and there is a need to discuss these issues at the level of Chief Ministers of the concerned States through the mediation of Minister for Water Resources.

Decision: Given the complex nature of these issues they were retained for the next meeting of the Northern Zonal Council.

- (v) **Appointment of Member in Bhakara Beas Management Board (BBMB) from Rajasthan**

Representative of Govt. of Rajasthan said that it has been proposed by Govt. of Rajasthan that Member, (Irrigation) in BBMB may be from Rajasthan. Representative of BBMB informed that Ministry of Home Affairs has intimated to have a 3rd member in the Board for which a proposal has already been moved by MHA for obtaining the necessary Cabinet approval.

Decision: Item retained. MHA to update.



1.7 Relining of Indira Gandhi Feeder (Punjab Portion) and Sirhind Feeder

(Sponsored by the Govt. of Rajasthan)

Ministry of Water Resources informed that a Cabinet note has been prepared and being put up. Chief Secretary, Govt. of Haryana informed that they have already given NOC for relining of Indira Gandhi Feeder and Sirhind Feeder. Considering the status, **the item was treated as resolved.**

1.8 Allocation of Coal Blocks and long term linkages of Gas to Rajasthan

(Sponsored by the Govt. of Rajasthan)

Representative of Ministry of Petroleum and Natural Gas intimated that due to dwindling supply of domestic gas, the supply of gas to power plants across the country has reduced. In view of the reduced gas supply from Gas fields, it has not been possible to allocate gas to various power projects. They further said, whatever gas is available it is to be supplied to the States through reverse bidding process for power plants. Representative of Ministry of Coal said that they have already allotted coal blocks to the State concerned and requested that the issue of coal block allocation may not be brought in the Council as it is done as per the existing guidelines. Hence, **the item was treated as resolved.**

1.9 Inter linking of rivers: Sarda-Yamuna-Rajasthan-Sabarmati link project.

(Sponsored by the Govt. of Rajasthan)

Representative of Ministry of Water Resources informed that the Detailed Project Report of the Pancheswar Multipurpose Project is being prepared and finalized by the Pancheswar Development Authority—recently constituted jointly by Governments of India and Nepal by considering the latest hydrological data. The feasibility report of the Sarda-Yamuna link project will be reviewed and revised on the basis of outcome of the final Detailed Project Report of Pancheswar project. Representative of Govt. of Rajasthan said that as per Supreme Court direction, this issue is to be discussed in the Committee headed by Minister of Power so it can be dropped. **The item was dropped.**

1.10 Setting up of Treatment Storage & Disposal Facility (TSDF) for disposal of hazardous waste of Delhi.

(Sponsored by the Govt. of NCT of Delhi)

Chief Secretary, Govt. of NCT of Delhi said that a plan has been worked out in which it was agreed by them and the Govt. of Haryana that for two years

Delhi would dispose of its hazardous waste at Paliin Haryana, while putting up their own Treatment Storage & Disposal Facility during this period. Once it is constructed the same amount of waste from Haryana would be treated in Delhi over the same period. However, the agreement needs to be finalised. Chief Secretary, Govt. of Haryana said that the issue is resolved but he requested that the CPCB should ensure that Delhi fulfils its part of the commitment.

Decision: The item was treated as retained till CPCB confirms it.

1.11 Curbing of Air Pollution in Delhi.

(Sponsored by the Govt. of NCT of Delhi)

Chief Secretary, Govt. of NCT of Delhi informed that some part of pollution is coming from neighbouring States. He also stated that Delhi is doing many things in this regard but action is being taken as per the order of NGT which is monitoring curbing of air pollution in the States. **Hence, the item was treated as resolved.**

2. Contamination of Water in Canals of Rajasthan off-taking from Harike Barrage

(Sponsored by Govt. of Rajasthan)

Representative of the Govt. of Rajasthan stated that it was an important issue for the State of Rajasthan, but it mostly relates to Punjab. Though they have prepared short term and long term plan in this regard but no time frame has been given by the State of Punjab. As no one attended the meeting from Punjab, **the item stayed unresolved.**

Decision: Item retained.

3. Registration of Deed and Documents.

(Sponsored by the Government of Rajasthan)

Secretary, ISCS observed that every state has specific Rules and Regulations in this regards arising out of its specific condition/situation, thus uniformity sought regarding registration of deeds and documents by Govt. of Rajasthan was seemingly incongruous. This was acknowledged by all other states, so **the item was dropped.**

4. Recovery of Excise revenue due from other States

(Sponsored by the Government of Rajasthan)

Though Govt. of Haryana took note of the request but it was felt that this item need not to be referred to the Zonal Council. The Standing Committee decided to **drop this item.**

5. **Non-recovery of share due from Govts. of Punjab and Haryana on Maintenance of Government Multi Specialty Hospital-16, Chandigarh.**

(Sponsored by the UT of Chandigarh)

Representative of UT of Chandigarh said that Govts. of Punjab and Haryana have given about 14 crores and 18 crores respectively for running of facilities in the Hospital but they should continue to do so as this emanates from a Central Act. Representative from Govt. of Punjab was not there to comment. However, Chief Secretary, Govt. of Haryana informed that correspondence is going on towards sorting out this issue. He proposed that Punjab, Haryana and Chandigarh would sit together to resolve it, which was agreed to by the Committee. **The item was treated as resolved.**

Item no. 6 to Item No. 8 below sponsored by the Govt. of NCT of Delhi were clubbed:

6. **Sharing of information and taking concerted action against Inter-State criminals particularly those involved in terrorism, heinous offences, criminal gangs or persistent offenders.**
7. **Steps to prevent human trafficking in NCR.**
8. **Need to check smuggling of drugs and illicit firearms.**

(Sponsored by the NCT of Delhi)

Chief Secretary, Govt. of NCT of Delhi said that in order to tackle the problem of missing children, PEHCHAN Scheme was launched. A photograph of the family with all children is taken and a copy of the photograph is given to the family for record, so that in case a child is reported missing, his/her photograph is available.

He further stated that easy availability of illicit arms and ammunition is a matter of concern. There is urgent need for regular exchange of information and inputs in the region on these matters. A Zonal Integrated Police Network (ZIPNET) project is already in operation between Delhi and neighbouring States. The main objective of the ZIPNET project is to *

maintain & share real time information of crime and criminals. Proper representation from all State police is required in the interstate coordination meeting for optimum utilization of this platform. Chief Secretary, Govt. of Haryana stated that there is already CCTNS project monitored by PMO through which data regarding crimes and criminals are shared among the States. Govt. of Rajasthan had similar view in that regard. Secretary, ISCS said that ZIPNET is somewhat a complement to CCTNS and in fact augment the efforts in tracking/prosecuting criminals, so it is worth emulating by the neighboring States of Delhi. States agreed to the suggestion.

Decision: Commissioner, Delhi Police would have a meeting with the DGPs of neighbouring States to impress the importance of sharing of information on all the above matters in order to deal with them effectively. These items were treated as resolved.

9. Support for Statistical Strengthening (SSS).

(Sponsored by Ministry of Statistics & Programme Implementation)

Chief Secretary, Govt. of NCT of Delhi informed that MOU has been formulated and signed but Delhi is not getting funds for its implementation. Representative of Ministry of Statistics & Programme implementation said that SSS is now a Central Sector Scheme and funds are released as per the guidelines. It was also stated that funds will now be released under the new scheme by the Ministry. Considering that all States have signed MOUs and formulated proposals, representative of Ministry of Statistics & Programme Implementation suggested that this item may be dropped. Committee treated the item as dropped.

10. Issues relating to MS&ME Entrepreneurs.

(Sponsored by the Ministry of Micro, Small & Medium Enterprises)

Representative of Ministry of Micro, Small & Medium Enterprises said that data bank in respect of unutilized land needs to be developed by the State Govts. for promoting entrepreneurs. Chief Secretary, Govt. of Haryana said that every state has its own industrial policy under which land is allocated to entrepreneurs. Chief Secretary, Govt. of NCT of Delhi also said that the State Govts. provide lands as per industrial guidelines. Considering that State Governments have taken action in the same issue suggested by Ministry of Micro, Small & Medium Enterprises the item was treated as resolved.

11. Implementation of Street Venders (Protection of Livelihood and Regulation of Street Vending) Act, 2014.

(Sponsored by the Ministry of Housing & Urban Poverty Alleviation)

Representative of Govt. of J&K informed that a Bill has been submitted regarding the street vendors; moreover, they have already started implementing it in Srinagar and some other towns. All the other States also informed that they are taking suitable action in the matter. As all States have been taking action in the matter, the item was treated as dropped.

12. 'Housing for all by 2022' - Issue relating to Slums encroachments on Central Government Lands.

(Sponsored by Ministry of Housing & Urban Poverty Alleviation)


Representative of Ministry of HUPA requested the States of Northern Zone to provide details of surplus lands belonging to Central Ministries and their PSEs in the States. Even though Govt. of J&K provided the details, it was understood that the matter is basically between HUPA and other Central Ministries possessing such surplus lands, thus HUPA may take up the matter with them. **In view of this the matter was dropped.**

13. Completion of ASIDE Scheme Projects under State Component

(Sponsored by the Ministry of Commerce & Industry)

Representative of Ministry of Commerce and Industry informed that ASIDE Scheme has been discontinued and requested that the item may be dropped now. However, representative of Govt. of J&K requested that the Central component of funds for the ongoing projects may be released by the Ministry. **Representative of Ministry of Commerce and Industry** informed that there was a meeting of Empowered Committee on the matter and it was decided to release the Central Component of funds to the States subject to achievement and commensuration to physical progress of work. It was informed that the State will expedite the execution of the project. It was further informed that the State has raised the DPR from the original 30 Crores to 90 Crores. It was stated by the representative of the Ministry that if the pace of progress picks up, they would have no objection in releasing the balance central funds.

Decision: The Committee decided that the decision of the Empowered Committee may be communicated to the state and requested the Ministry to release the Central Component of fund to the States quickly. With this recommendation, the item was treated as resolved.



14. Modernization of Police Force.

(Sponsored by the Ministry of Home Affairs)

Representative of Ministry of Home Affairs said that under MPF since last year there is no plan component and they have been releasing funds only under non-plan component, but there was a meeting of the Parliamentary Standing Committee where in it was recommended that a plan component should be brought back. Therefore, there would be a plan component too for construction activities. There would be a new scheme for three years from the next year (2017-18 to 2019-20). Funds for the earlier schemes have been released to both the Govts. of Himachal Pradesh and J&K as they had submitted the UCs for most funds spent. Representative of Govt. of J&K stated that UCs worth Rs. 10 Crores are pending with them which would be submitted soon and for the funds released to them recently they said it would be utilized and UC would be sent soon. Chief Secretary, Govt. of J&K pointed out that as per the recommendation of the Committee of Chief Ministers appointed by NITI Aayog, the scheme of Police Modernization should continue as Centrally Sponsored Scheme as it was already accepted by the Ministry of Finance. The Standing Committee endorsed the view. Given the development in the matter, the item was treated as resolved.

15. Allocation of suitable land against Key Location Plans (KLPs) to Central Armed Police Forces


(Sponsored by the Ministry of Home Affairs)

Representative of Ministry of Home Affairs informed that the State Govt. of J&K have not provided lands against Key Location Plans to Central Armed Police Forces. Chief Secretary, Govt. of J&K said that they are holding monthly meeting for demarcation of land to flag the issue. He assured that the matter would be resolved soon and requested the Committee to drop the item. Based on the assurance the item was treated as resolved:

Item Nos. 16 to 23 were sponsored by Ministry of Health & Family Welfare, which are as follows:

16. National Tobacco Control Programme (NTCP).

- (a) Banning food products containing tobacco or nicotine such as Gutkha under Section 2.3.4 of the FSSAI Act, 2006.
- (b) Effective implementation of Cigarettes and Other Tobacco Products (Amendment) Rules, 2005 providing specifications



for advertisement at the entrance of or inside a shop or warehouse selling tobacco products (point of sale) – POS Rules.

17. **National Programme for Prevention & Control of Deafness (NPPCD).**
18. **Effective implementation of Good Samaritan Guidelines for Road Traffic Accident victims as advised by the Hon'ble Supreme Court.**
19. **Effective implementation of advisory issued by the Ministry of Health & Family Welfare to follow the pre-Hospital Trauma Technician course**
20. **Trauma Care System Plan**
21. **Effective implementation of Section 357-C inserted in Code of Criminal Procedure, 1973 requiring hospitals to provide first-aid/ medical treatment, free of cost to victims acid attack**
22. **Banning of sale of acid across the counter**
23. **National Aids Control Organization**

The Standing Committee observed that all the above issues stem from the advisories issued from time to time by the Central Govt. to be implemented by the State Govts. As appropriate actions were being taken by all the States in these matters, with the consent of the representative of Ministry of Health & Family Welfare, the items were treated as dropped.

24. **Setting up of Mini Hydel Projects on Bhakra Main Line Canal at 27 Sites in Punjab with generation capacity of 63.75MW of power.**

(Sponsored by Ministry of New and Renewable Energy)

Chairman, BBMB said that there are several hydel projects proposed on Bhakra Main Line Canal in Punjab but these get stymied as other States are not agreeing to these. ISCS informed that Hon'ble Home Minister would chair a meeting on 20.6.2016 in order to arrive at a consensus on this issue as Govts. of Haryana and Rajasthan lay claim on the power to be produced in these hydel projects which are not agreeable to the Govt. of Punjab.

Representative of Ministry of Power meanwhile urged that ongoing dispute on this matter has resulted in continuous loss of energy which would be available at 50 paise per unit only if the dispute could be resolved. It was, therefore, imperative that States may take a conciliatory approach towards solving this issue. **Chairman, BBMB** said that Ministry of Power is the Nodal Ministry and the issue may be resolved by them in consultation with the concerned State Govts. Secretary, ISCS requested Ministry of Power to work out 3-4 options to sort out this issue.

Decision: Standing Committee suggested that a meeting may be convened by Secretary, Ministry of Power with the representative of State Governments of Himachal Pradesh, Haryana, Punjab and Rajasthan to look into the possible ways of resolving the issue. Item retained.

Addl. Agenda item:

1. **Precautionary measures to be taken by State Governments for Students and businessmen to prevent harassment in other States.**

(Suggested by Government of J&K)

Representative of Govt. of J&K informed that instances have come to the notice of Government of J&K wherein students and the business persons belonging to the State have been the victim of harassment in neighbouring can be exploited by inimical elements to justify their subversive activities in the State. In such cases, the State concerned should take immediate preventive and precautionary measures. It was also requested that a Nodal Officer should be appointed by each State Governments to deal with these instances in a coordinated and effective way. Representative of MHA informed that as per advisory already issued by them to the State Governments, Nodal Officer may be appointed by each member State to share the information in cases of harassment of J&K residents. apart from taking other appropriate measures to curb such incidents. All State Govts. assured that requisite actions are being taken by them including the appointment of Nodal officers. In view of the above, the item was dropped.

The meeting ended with vote of thanks to the Chair.

Representative of Ministry of Power meanwhile urged that ongoing dispute on this matter has resulted in continuous loss of energy which would be available at 50 paise per unit only if the dispute could be resolved. It was, therefore, imperative that States may take a conciliatory approach towards solving this issue. **Chairman, BBMB** said that Ministry of Power is the Nodal Ministry and the issue may be resolved by them in consultation with the concerned State Govts. Secretary, ISCS requested Ministry of Power to work out 3-4 options to sort out this issue.

Decision: Standing Committee suggested that a meeting may be convened by Secretary, Ministry of Power with the representative of State Governments of Himachal Pradesh, Haryana, Punjab and Rajasthan to look into the possible ways of resolving the issue. Item retained.

It was also requested that a Nodal Officer should be appointed by each State Governments to deal with these instances in a coordinated and effective way.
