Subject:- Regarding enhancement of upper age limit for entry into Government Service

Sir/Madam

I am directed to address you on the subject noted above and to state that various Unions/Federations of the employees of Chandigarh Administration have been demanding for enhancement of upper age limit for entry into government service on Punjab pattern. The matter has been considered by this Administration in depth to redress the long standing demand of Unions/Federations of the employees of Chandigarh Administration as well as that of job seekers and to provide avenues of employment to the aspiring youth in the U.T. Chandigarh, it has been decided to enhance the age limit for first entry into government service (in direct recruitment) for all technical and non-technical posts in Chandigarh Administration from 18-25 years to 18-37 years on Punjab pattern. In other words, the upper age limit has been enhanced from 25 years to 37 years on the pattern of Punjab Government.

You are, therefore, requested to carry out the necessary amendment in the Service/Recruitment Rules with the approval of the competent authority. There is no need to refer the case/ proposal to the Department of Personnel for concurrence in this regard, anymore.
