Subject:- Maintaining a common seniority list for appointment on compassionate grounds.

Sir/Madam,

I am directed to address you on the subject noted above and to state that due to small size of various departments in Chandigarh Administration, the family members of deceased government employees do not get appointment on compassionate grounds for many years. In order to lessen the hardships being faced by the dependent family members of the deceased government employee(s), the matter has been considered by this Administration in depth and it has been decided that a common seniority list may be maintained by the Regional Employment Officer, Union Territory, Chandigarh.

2. On the recommendations of the Committee constituted by the concerned department for considering the request of dependant family member of deceased government employee for appointment on compassionate grounds, the name & particulars of the eligible dependent family member of the deceased government employee will be sent to the Regional Employment Officer, Union Territory, Chandigarh for maintaining a common seniority list for appointment on compassionate grounds. As and when, a vacancy (Group C or D) for appointment on compassionate grounds becomes available in any department of the Chandigarh Administration, the same will be filled up from the common seniority list maintained by the Regional Employment Officer, U.T. Chandigarh.
3. The entire process will be done online also.
4. The contents of this communication may kindly be brought to the notice of all officers/officials working under your control for strict compliance.
5. This has the approval of the Administrator, Union Territory, Chandigarh.


