- 4. Leakage/Seepage near Nursing Counter of Area 71, Block C.
- 5. Seepage & Leakage in room of Pulmonary Medicine Ward, Level VI, Block C.
- 6. Seepage in MMW, Area 62, Block C.
- 7. Leakage in FSW, Block A in Room No.3203 & 3206.
- 8. Leakage from ducts of Block 'A'.

- 2. ADA asked the SDE-PH to provide the list/detail of staff posted in GMCH for AC plants and Fire Firghting purpose with their roster and contact nos.

MAIN PENDING ISSUES REGARDING HORTICULTURE:-

- 2. Nobody is posted for disposal of dry leaves in UHTC Sh. Narinder Pal, JE assured to do the work.
