Subject:- Extension in Service to the employees of Chandigarh Administration.

Sir/Madam,

In continuation of this department's order issued bearing Endst. No. 34/55-IH(7)-2012/23059-62 dated 07.12.2012 and circular letter No. 34/55-IH(7)-2013/3059 dated 19.02.2013, I am directed to address you on the subject noted above and to state that the Chandigarh Administration has referred the proposal for adoption of Punjab Government's circular letter No. 22/2/2012-3FP2/475 dated 08.10.2012 for granting one year extension in service beyond superannuation to the willing Group A, B, C and D employees of the Chandigarh Administration to the Ministry of Home Affairs. As an interim measure it has been decided to grant extension in service for a period of another three months beyond 30.04.2013 (i.e. 30.04.2013 to 31.07.2013) to the superannuating Union Territory employees on the pattern of Punjab Government till further orders.

2. It is clarified that the above order will be applicable to all Group A, B, C and D employees who have already been given extension and will superannuate in future.
3. The terms and conditions for granting extension/continuation in service beyond the date of superannuation will remain the same as already mentioned in order/circular dated 07.12.2012 and 19.02.2013 referred to above.
4. This is subject to amendments which may become necessary due to subsequent amendments made by the Government of Punjab or any difficulty being faced by the Chandigarh Administration.
