Subject :- General election to Panchayat Samiti and Zila Parishad, U.T., Chandigarh, to be held in the last week of May, 2017 - Model Code of Conduct.

Sir,

I am directed to state that it has been decided to hold General election to Panchayat Samiti and Zila Parishad, U.T., Chandigarh. The programme of election will be notified by the Commission on 12.05.2017. With this announcement, the Model Code of Conduct (copy enclosed) shall come into force in the area of 12 Gram Panchayats in U.T., Chandigarh with effect from 12.05.2017 and shall continue to be in force upto the declaration of result of the said election i.e. 30.05.2017. It is requested, that the contents of the Model Code of Conduct may kindly be brought to the notice of all concerned immediately, and cases of violation, if any, brought to the notice of this Commission.

The police authorities may examine the law and order position in the above mentioned villages and in and around all the polling stations being set up for the above-said election (a copy of list of polling stations will be sent shortly), throughout the period of election commencing from 12.05.2017 to 30.05.2017. A list of sensitive polling stations may kindly be sent to this Commission for further necessary action, immediately. A daily law and order report in respect of the above Gram Panchayats areas may also please be sent to this Commission daily from 12.05.2017 to 30.05.2017.

The Chandigarh Administration is requested to kindly ensure that no Officer/Official deployed on election duty is transferred from his/her present department/place of posting, during the aforesaid period.

Attention of the Chandigarh Administration is invited to item VII of the Model Code of Conduct with the request that the requisite restraints be enforced as envisaged therein in respect of any scheme of a general nature where voters of the said village are the beneficiaries in general or in particular and could be influenced by the party in power, should strictly be avoided during the aforesaid period.

Action taken in the matter may kindly be confirmed to this Commission urgently.

Kindly accord the matter **TOP PRIORITY**.
