As you are aware the Central Armed Police Forces (CAPFs, i.e., CRPF, BSF, CISF, ITBP and SSB) are engaged in border guarding as well as for the internal security operations in the States. State/UT Governments have frequently seeking assistance of these Central Armed Police Forces to maintain law and order in their States during elections, disaster management, communal riots and natural calamities, etc. deployments have now become a regular feature, particularly with regards to the left wing extremism, J&K and North East. The CAPF personnel discharge all these duties to the best of their abilities and many of the force personnel lay down their lives while many others get incapacitated while performing such duties while assisting the State Governments concerned.

CAPF personnel work in extremely hard areas like North East, Jammu & Kashmir and the Left Wing Extremism affected areas in many parts of the country as also are deployed in the most challenging situations like disaster management, communal riots, security of vital installations, etc., in aid to civil powers of the State/UT Governments concerned.

The Border Security Force (BSF) is deployed on international Borders with Pakistan and Bangladesh, Indo-Tibetan Border Police (ITBP) is deployed on the Indo-China borders and Sashastra Seema Bal (SSB) on the Indo-Nepal and Indo-Bhutan borders. These CAPFs are working hard to ward off intrusions, infiltration, smuggling of arms, drugs, etc., in their a respective areas of deployment.

In view of the difficult working conditions of the CAPFs personnel, a demand/concern was raised in various quarters for providing some of the facilities / entitlements available from the State/UT Governments to the retired CAPF personnel who are ultimately the subject of the State concerned in which they finally settle after their retirement.
