

MINUTES OF THE MEETING OF THE HOME MINISTER'S ADVISORY COMMITTEE FOR THE UT OF CHANDIGARH HELD ON 27.07.2017.

List of participants is enclosed.

2. The Hon'ble Home Minister welcomed the Members of the Committee and remarked that the Committee is meeting after about a period of 11 years. After the brief introduction of the participants, the agenda items were taken up one by one and the decisions taken on each of the issues are as under:-

(1) Conversion of Residential Leasehold properties into freehold properties in Chandigarh

This issue was raised by Hon'ble MP, Chandigarh who requested that the matter may be settled in a time bound manner. The committee was apprised that comments of Ministry of Urban Development were invited and on receipt of the same Chandigarh Administration has been requested to offer their comments. Chandigarh Administration was advised that the rate of land should be revised so that there is no loss to exchequer of the Government. The Chandigarh Administration was advised to take action and submit the same to MHA.

(Action: Chandigarh Administration)

(2) CWP no. 22636/2013 titled as Phool Kumar Saini Vs. Chandigarh Housing Board and others - Regarding UT Employees Self Financing Housing Scheme, 2008.

The matter is under consideration of the Ministry of Home Affairs.

(Action: Ministry of Home Affairs)

(3) Amendment in the Capital of Punjab (Development & Regulation) Act, 1952 to incorporate enabling provisions for revision of penalty to be imposed in cases of building violations and misuse of premises in Chandigarh.

The matter is under examination and the same is being referred to Department of Legal Affairs along with the response received from the Chandigarh Administration vide their letter dated 22.06.2017. Chandigarh Administration was advised to rationalize the rates of penalties and submit the same to MHA.

(Action: UT Administration)

(4) Policy for land allotment

The proposal of Chandigarh Administration regarding relaxation in policy for attachment of land for the construction of Government offices and such institutions that are meant for public use was processed in this Ministry and the same was not agreed to. The same was conveyed to Chandigarh Administration vide this Ministry's letter dated 12.06.2017. However, UT Administration has requested to reconsider the issue as they are not in able to allot the land even for institutions meant for public use. It was decided that the Chandigarh Administration shall refer the matter again to MHA for re-consideration.

(Action: UT Administration/MHA)

(5) Subsistence allowance of Home Guards

Committee was informed that the Department of Expenditure concurred/approved the proposal of Chandigarh Administration.

(6) Regulatory body to regulate fee and other charges in r/o recognized schools of UT Chandigarh.

The proposal to extend the provisions of "The Punjab Regulation of Fee of Unaided Education Institutions Act, 2016" to UT of Chandigarh was received in this Ministry on 11.05.2017 and it has been referred to Ministry of Human Resource and Development (MHRD) on 16.05.2017 for their comments. The representative of MHRD stated that they will furnish their comments on priority.

(Action: MHRD)

(7) Extension of the court fee (Punjab Amendment) Act, 2016 to the Union Territory of Chandigarh

Committee was informed that the notification in this regard has already been approved.

(8) Approval for user charges collected by the hospital/health facilities to be deposited in the Rogi Kalyan Samiti

Representative of Ministry of Health & Family Welfare apprised the committee that revenue generated through user charges collected by the hospital/health facilities should be deposited with Rogi Kalyan Samiti. Presently it is being deposited in Consolidated Fund of India.

(Action: UT Administration)

(9) Appointment on compassionate ground on Punjab pattern.

The said proposal was received from Chandigarh Administration and after examination certain clarification were sought from Chandigarh Administration vide this Ministry's letter dated 21.04.2017. In pursuance, Chandigarh Administration vide their letter dated 08.05.2017 clarified the observations of this Ministry. The representative of DOPT stated that in view of Supreme Court Judgment (in a similar case), it may not be agreed. Committee noted the same.

(10) Extension of security of Service Act in respect of employees of aided schools of UT Chandigarh

The said proposal was not received earlier in the Ministry. However, the same has now been received and will be examined.

(Action: MHA)

(11) Reservation in promotion

The letter dated 05.06.2017 on this issue was received in this Ministry. It has been forwarded to Ministry of Personnel, Public Grievances and Pensions with a request to send the desired information to Chandigarh Administration directly under intimation to this Ministry. The representative of DOPT apprised the committee that since the matter is sub-judice, no decision can be taken at this stage. The Committee noted the same.

(12) Grant of Pension Scheme to the employees of privately managed Government Aided Colleges

The proposal of Chandigarh Administration has been referred to Ministry of Human Resource Development(MHRD) for their comments/views on the issues raised by Chandigarh Administration. Representative of MHRD informed the Committee that this is a policy decision. MHRD was requested to expedite their comments.

(Action: MHRD)

(13) Proposal for separate cell for implementation of persons with Disabilities Act, 1995

The representative of Ministry of Social Justice & Empowerment apprised the committee that there is no separate Cell for implementation of persons with Disabilities Act, 1995, in any UTs and Department looking after Social Security should ensure its implementation. This proposal may not be agreed. The Committee noted the same.

(14) Implementation of Right of Persons with Disabilities Act, 2016

The request of UT Administration was to intimate whether any instructions regarding implementation of Right of Person with Disability Act, 2016 has been issued by the Department of Empowerment of Persons with Disabilities wherein benefits of reservation for Persons with Disabilities to the extent of 4% has been given. The representative of Ministry of Social Justice & Empowerment informed the committee that the provision regarding benefit of reservation for persons with disabilities to the extent of 3% is for entire country. The Committee noted the same.

(15) Simplifying the building bye laws for Chandigarh

This issue was raised by Shri Sanjay Tandon and Shri Kailash Chand Jain, members of HMAc. The Committee was apprised by the HMAc members that the existing building bye laws must be simplified by denotifying the rate of Rs. 500/- per sq. ft. monthly penalty. The Chandigarh Administration apprised the Committee that they have already reduced rates of penalty to be calculated on area under misuse/violation of various categories vide notification dated 28.03.2016. It was decided that UT Administration of Chandigarh would examine it for further appropriate action.

(Action: UT Administration)

(16) Permitting optimum use of available commercial spaces

This issue was raised by Shri Sanjay Tandon, Ms. Asha Kumari Jaiswal and Shri Kailash Chand Jain, members of HMAc. They suggested optimum use of commercial buildings by allowing general trade including catering and rent house hiring. The Chandigarh Administration apprised the Committee that the provision of partition in SCO has already been made in the Chandigarh Building Rules (Urban) – 2017 and amalgamation of booths was mentioned in draft Chandigarh Building Rules (Urban) – 2017. It was decided that UT Administration will further examine the issue and take decision. In case any approval is required, UT Administration may send a proposal.

(Action: UT Administration)

(17) Transfer of small booths

This issue was raised by Shri Kailash Chand Jain, member of HMAc. He apprised the Committee that small booths were allotted to

small traders and there was 15 years lock in period for transfer of these booths. And after 15 years if booths are sold, Administration is charging 50% of profits which is unjustified. UT Administration informed the Committee that these booths were allotted to the beneficiaries under various schemes on basis of eligibility. The price of these booths is not same as that fetched in open auction. There is condition/bar for not selling the booth for 15 years in their allotment letter so as to restrain the beneficiaries from making a profit on allotted booths. However, it was advised that UT Administration needs to examine the issue further and take decision. In case any clarification is required, UT Administration may send a proposal.

(Action: UT Administration)

(18) Model Rent Act

This issue was need for a model balanced rent act for Chandigarh which looks after the interests of both the tenants as well as those of the landlords. UT Administration apprised the committee that they have started action in this regard. It was informed by representative of Ministry of Housing and Urban Affairs(MHUA) that they are making a Model Rent act and UT Administration may examine and adopt the same.

(Action: UT Administration; MHUA)

(19) Establishment of Traders Welfare Board

Shri Kailash Chand Jain, member of HMAC impressed the need for a Traders Welfare Board. UT Administration apprised the committee that no proposal has been received on this issue. In case any proposal is received appropriate action shall be taken by UT Administration.

(Action: UT Administration)

(20) Smart city development

Shri Kailash Chand Jain, member of HMAC submitted that a sum of Rs.500 crores spread over 5 years is too meagre amount for development of Chandigarh into a real smart city. UT Administration was advised to look into the matter and take appropriate action.

(Action: UT Administration)

(21) Trading under GST

There was a demand that the trade among Chandigarh, Panchkula and Mohali be treated as within state trade instead of interstate trade.

UT Administration was advised to examine the issue and if required send proposal to MHA for consideration of Department of Revenue.

(Action: UT Administration)

(22) Optimization of resources

The issue concerns optimum utilization of available land resources and its future planning. UT Administration apprised the Committee that optimization and planning of available land has been taken care of in the provisions of Chandigarh Master Plan – 2031 which will be implemented.

(Action: UT Administration)

(23) Citizen charter act be implemented

The Chandigarh Administration apprised the Committee that they have already uploaded Citizen Charter on the official website of the Chandigarh Administration. The Committee noted the same.

(24) Grievance redressal mechanism of all the public dealing department for quick disposals of public grievances, be constituted

Committee was apprised that GOI has already launched website pgportal.gov.in-"CPGRAMS" to address the grievances of general public promptly. On this portal all kinds of grievances may be addressed. The Committee noted the same.

(25) In order to preserve the architectural heritage of city, Chandigarh need to have Urban Arts commission on the pattern of New Delhi

This issue was raised by Shri Surinder Bahga, member of HIMAC who suggested that Chandigarh need to have Urban Arts Commission on the pattern of New Delhi. The UT Administration apprised that there exists Chandigarh Heritage Conservation Committee (CHCC) meant for the same purpose. The Committee noted the same.

(26) Two studies have indicated that Metro Rail is not feasible proposal in Chandigarh.

The matter was deliberated at length. It was decided that the metro project for Chandigarh is not commercially viable. The Committee noted the same.

(27) Chandigarh is afflicted with problems of traffic congestion and shortage of parking space.

UT Administration stated that by strengthening the existing city public transportation system will decrease the existing congestion on arterials. Secondly, a draft parking policy has been prepared and forwarded to various departments of Chandigarh administration for their comments and will be finalised by UT Administration.

(Action: UT Administration)

(28) The problem of solid waste management and solid waste treatment is not solved due to various reasons, It should be addressed on priority.

UT Administration stated that there is no exit clause in the contract already made with the existing JP Associates. The matter was deliberated at length and it was decided that UT Administration will try to settle the issue by exploring all possibilities.

(Action: UT Administration)

(29) Huge railings are being installed on many city roads and markets which were not needed.

UT Administration has started this project on pilot project basis keeping in view the safety aspects. Further action shall be taken after examining the pros and cons of this pilot project.

(Action: UT Administration)

(30) Need for vehicular underpasses/overpasses as proposed by Le Corbusier to smoothen the flow of traffic in Chandigarh.

The provisions as given in the CMP-2031/RITES should be implemented. It is a known fact that the beautiful city is already overburdened with increasing number of cars and two wheelers. Hence, investments and measures to strengthen the existing city public transportation system should be made.

(Action : UT Administration)

(31) About 2000 acres of land around seasonal rivulets of Patiala ki rao and Sukhna Choe can be developed as leisure valleys

The provision in this regard has already been made in the Chandigarh Master Plan -2031

(Action: UT Administration)

(32) Adoption of recommendations of 4th Delhi Finance Commission issued in the month of August, 2014 for increasing the revenue share of Municipal Corporation from existing 17.5% to 30% of the UT revenues

This issue was raised by Smt. Asha Kumari Jaswal, Mayor, member of HMAC. UT Administration apprised the Committee that a meeting was held under the chairmanship of Finance Secretary, Chandigarh Administration wherein it was decided that Municipal Corporation will send the income and expenditure report on the format prescribed by the Finance Secretary. The Municipal Corporation has now supplied the requisite information and assessment of the same is under consideration.

(Action: UT Administration)

(33) Setting up of Commission/Bench of Human Right Commission/ Women Commission / SC Commission in Chandigarh

The UT Administration apprised the Committee that they have examined the proposal and it has not been felt desirable for setting up of a separate Commission/Bench of Human Right Commission/ Women Commission / SC Commission in Chandigarh. The Committee noted the same.

(34) The post of Senior Superintendent of Police may be filled up by promotion amongst DSPs of Chandigarh Police as per existing rules.

The UT Administration apprised the Committee that the post of SSP is filled up on inter cadre deputation from amongst the IPS Officers of AGMUT cadre.

(Action: UT Administration)

(35) The post of Deputy Superintendent of Police in UT Chandigarh may be filled up by promotion instead of deputation from New Delhi

The UT Administration apprised the Committee that draft recruitment rules for filling up of the post of DSPs have been forwarded to GOI by prescribing the following mode of recruitment:-

Total sanctioned posts – 22

- i) By promotion (45%) -10
- ii) From DANIPS(32%) - 07
- iii) From Punjab (13%) - 03
- iv) From Haryana (10%) - 02

(Action: UT Administration/MHA)

(36) Chandigarh Police Officers to be inducted in IPS as per quota and pattern of all UTs and States of India.

UT Administration apprised the Committee that all the IPS officers are being taken on inter cadre deputation basis from state of Punjab, Haryana and AGMUT cadre. Chandigarh Administration has not received any formal proposal for separate cadre of Chandigarh in IPS.

(Action: UT Administration)

(37) Policy may be framed for the regularization of services for the employees appointed on contractual basis.

The UT Administration apprised the Committee that their personnel department has advised not to regularize the service of contractual staff as per the ruling of Hon'ble Supreme Court in Uma Devi Case. The Committee noted.

(38) Implementation of Punjab/Hindi language as official language

UT Administration apprised the Committee that they follow the instructions issued by MHA/GOI which indicates that official language of UT of Chandigarh is English but most of the name/notice/sign boards use Punjabi, Hindi & English. Moreover letter to UT Administration are replied in the language of applicant/writer. However a proposal in this regard may be sent to MHA for examination.

(Action: UT Administration)

(39) Laldora issue of the rural belt in Chandigarh, meanwhile permission for putting up solar energy generation panels in rural area.

A proposal through Director, Science and Technology was made to install solar panels in reserved peripheral areas of Chandigarh. UT Administration apprised the Committee that this proposal was not agreed by UT Administration in view of the violation of Periphery Control Act and future requirement of land.

(Action: UT Administration)

(40) Help/subsidy for subsidization of Tirath Yatra like Kailash Mansarovar

Finance Department has accorded approval for according financial assistance to the tune of Rs. 50000/- for first three tirath yatri of Kailash

Mansarovar Yatra. Case for the final approval has been sent to HE the Administrator in July 2017.

(Action: UT Administration)

(41) Formation of Women Social Welfare Board is lying pending which needs to be expedited

UT Administration has already sent the names for the Chairperson and two members for Social Welfare Board (SWB) as approved by the Administrator. The Deputy Director, Central Social Welfare Board has asked for a panel of three names for the post of Chairman of SWB. The matter is under process.

(Action: UT Administration)

(42) Flatwise/sharewise execution of conveyance deeds to the allottees of Cooperative House Building Societies in Chandigarh.

UT Administration apprised the Committee that the matter is being dealt by Estate Branch of Chandigarh Administration and is under active consideration.

(Action: UT Administration)

(43) Pending issues of Chandigarh Union Territory in MHA need to be resolved immediately and a separate table/officer may be considered to whom the Chandigarh issues are addressed and sorted immediately

Director (ANL), UT Division has been nominated for this purpose. The Committee noted the same.

(44) Transfer of department from the Administration to the Corporation with supporting budget

UT Administration apprised the Committee that as per the decision taken in 242nd meeting of the House of MCC held on 28.2.2017, it was resolved that primary health department be transferred full-fledged to the Corporation. Thereafter as per the directions of HE the Administrator Department of Health Service (DHS) has been requested to prepare a plan for each dispensary regarding up gradation of infrastructure/ manpower etc. before such transfer.

(Action: UT Administration)

(45) Reservation in Government jobs in Chandigarh for the Chandigarh domiciles or eligibility to be granted to Chandigarh domiciles for the jobs in Haryana

Shri Sanjay Tandon, member of HMAC suggested that the government job in Chandigarh may be reserved for Chandigarh domiciles holders or the Chandigarh domiciles holders be given privilege for jobs in Haryana. The UT Administration apprised the Committee that as per RR of various posts of the Government of Punjab & Haryana, any citizen of India who fulfils the requisite criteria laid down in the advertisement can apply for unreserved post irrespective of the fact whether he/she is a permanent resident (domicile) of Punjab & Haryana or not. The Committee noted the same.

(46) There is a need to transfer the ownership rights to the residents of EWS colony and Tenement Colony.

This issue was raised by Shri Sanjay Tandon, member of HMAC. The UT Administration apprised the Committee that there are approximately 31000 EWS/Tenants allotted by Estate Office under various schemes. The State Officer has been directed by Chandigarh Administration to conduct physical verification. On completion of physical verification UT Administration will send proposal to Ministry of Housing & Urban Affairs for necessary approval.
