Sir/Madam,

I am directed to refer to this Administration's letter No. 7032-IH(11)-2017/23064 dated 21.09.2017, whereby it has been decided that all the posts to be filled up on regular, contract, through outsource, D.C. rates etc. should be advertised in the newspapers and also uploaded on the official website of the departments.

2. Various departments have been requesting not to include the filling up of the vacancies through outsource/DC rates stating that they are facing hardship in filling up the posts through outsource, as the employees are provided by the contractor and the departments have no direct employer/employee relation with the persons so provided through outsource.



The matter has been re-considered and it has been decided that henceforth only the posts to be filled up on regular basis and on direct contract basis should be advertised in the newspapers and also uploaded on the official website of the departments. However, for outsourcing the services/activities, the departments shall strictly follow the procedure laid down in the relevant rules and instructions issued by the Chandigarh Administration from time to time.
