2. To fulfil the GoI vision of "Less Paper Office", various initiatives for overall increasing the efficiency of the officers and speeding up office procedure is being taken up. Also to make work more collaborative and for anytime availability of officials to discuss important matters irrespective of geographical locations, a software based video conferencing system has been procured by National Informatics Centre (NIC) from M/s Vidyo Inc. with over 4000 licenses.

3. This video Conferencing system is available to use with various Government Departments, Line Ministries and attached offices with the purpose of anytime VC connectivity between officials for better governance of the schemes. Department of Justice and Social Welfare has extensively utilized with VC system for Mission Mode Project (MMP) of eCourts. All the Officers in Ministry of Health and Family Welfare are using this Video Conferencing application.

4. Ministry of Health and Family Welfare has already registered accounts of Principal Secretaries and Mission Directors in this application (a list of which is enclosed herewith). The system could be utilized by the State Officials for day to day discussion on non-emergency matters, virtual review meetings and discussion with peers and Officers in MoHFW where the personal attendance of the participant is not needed much.

5. The Username of Officers is their email Id and the default password for logging into this application is 1234. It must be noted that this password is only for distribution

purpose and the same may be changed after logging in to account. Local NIC may be contacted to install the application from <http://webvc.nic.in>. User Manual is also enclosed herewith.
