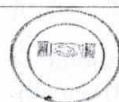

**NOTE:-**

1. As per Constitution of the Association, the candidate(s) for the post of President and general Secretary will be from Secretarial and Clerical Cadre respectively or vice-versa. Therefore, prospective candidate for President would be from secretarial cadre only and for General Secretary from Clerical Cadre or vice-versa. As such it is hereby made clear that when a candidate for the post of President is elected from the secretarial cadre, then the post of General Secretary will automatically go to clerical cadre and vice-versa.
2. If, both the candidates i.e. President and General Secretary are elected from the single cadre i.e. Secretarial or Clerical Cadre, the Chief Election Officer will decide on the same day as per provisions of the constitution.
3. One post is reserved for female candidate out of 08 posts. The post will also be decided by the Chief Election Officer as per the nominations.
4. Copy of the constitution is also handed over to the Chief Election Officer with request to follow the procedures as laid down in the Constitution.

- Date of withdrawal of nomination papers 15.02.2018 (5 p.m.)
- Date of Election (from 9 am to 1 pm) 17.02.2018

**Nominations :** Nomination for President shall be proposed by at least 05 eligible members of the Association while for other office bearers it shall be by 02 members.
