Regarding treatment of prisoners in the hospitals.

Sir,

With reference to this office letter no. 205-208 dated 11.01.2017 on the subject cited above, it is stated that the prisoners referred to hospitals for various treatment and they are called for follow ups and investigations as part of their treatment. However, it has been observed that many of them are examined by the training/junior doctors only and sometimes the signatures of the doctors who have recommended follow ups or treatment are not available on the prescriptions written on medical cards. It has also been observed that some prisoners are being called to the hospitals frequently for treatment. The number of their visits exceed 60 times in a year which can easily jeopardize the security or the jail as well as hospitals. The treatment of the inmate is mandatory but such frequent visits to the hospitals are not in the interest of security of the jail.

In view of the above, it is again requested that instructions may kindly be passed to all the departments that inmates visiting to hospitals from jail may be given minimum follow ups (only when required urgently) to avoid any untoward incident in future.
