It has been decided by the competent authority that the security amount for the Private Room as well as General Ward admissions are hereby revised with immediate effect.

Sr.No.	Security deposit for	Existing	Revised
1.	Private Wards	Rs.5,000/-	Rs.10,000/-
2.	General Wards	Rs. 200/-	Rs. 1,000/-

- The additional security of Rs.5000/- for private ward and additional security of Rs.1000/- for General Wards will be used for the investigations being prescribed by the treating doctors during the admission.
- The additional security of Rs.5000/- and Rs.1,000/- will not be used for spending on CT Scan/ MRI .
- It was also decided that already existing security will continue as such in case of employees of UT, Chandigarh and Punjab & Haryana High Court, as no investigation charges are being paid by them.
- For ordering the investigations from the respective ward, no hard copies of the investigations form will be required; however, information for investigation will be transferred to the respective lab online.
- The payments for investigations prescribed during the admission will be adjusted at the time of discharge. However, subsequently, the software prepared by the NIC will have the inbuilt facility of deduction of amount at the time of ordering the investigation from the advance paid.
