Respected Shri Sachdevji,

You may be aware that Employees' Provident Fund Organization, an Autonomous Body under Ministry of Labour and Employment, Government of India has been mandated for extending old age and retirement benefits under **Employees' Provident Fund and Miscellaneous Provisions Act, 1952 (Act 19 of 1952)** to the poor workers. This office administers three schemes of Social Security framed under the EPF & MP Act, 1952. These Schemes ensure the retirement benefits i.e. payment of PF accumulation disbursement of monthly Pension, if eligible, and in case of unfortunate death of an employee in the employment, insurance benefit.

The benefits are of utmost importance for the employees after their retirement and can be extended only if they are aware of their PF Account number. During a recent interaction of Shri K.K. Jalan, IAS, Central PF Commissioner with various Trade Union representatives and employers at Chandigarh, it has come to the notice of department that a large no. of EPF members especially the contractual workers are not aware of their PF Account number. As a proactive measure to redress this grievance of the members the following steps can be taken.

A list of employees including contractual employees having the details of PF Account Number may be displayed on the Notice Board of your establishment. The Attendance Register maintained for the contractual workers and the wage/salary register may also have the details of PF Account Number of the member. A facility may also be provided in your office where any employee can check the status of their PF Account on the website of the EPFO i.e. www.epfindia.com.

Your cooperation in the matter is solicited.
