MINUTES OF THE MEETING

The Committee constituted vide no. GMCH-HA-II-EA3(15)/2018/17498-503 dated 22.05.2018, met in the office of the Chairperson on 30.07.18 at 3.00 pm to discuss the matter regarding difficulty and problems in opining regarding MLC X-rays. After deliberations, the Committee was of the opinion that:

1. At present, the departments of Orthopaedics, Surgery and any other department dealing with medico-legal cases, wherein, Radiological investigations are required should send two requisition forms, one for MLC and one for treatment purpose.
2. Meanwhile, the department of Radiology will try to have filters for MLC cases in the digital X-rays software, so that the MLC X-rays can be stored in the hardware and be retrieved by the doctors of the department for giving their opinion, whenever requested by the other departments or by the investigating officials.
3. The Committee also recommends that the department of Radiology should be equipped with extra increased computer storage capacity including backup storage for medico-legal X-rays, CT scans and MRIs, as it would take long time in the courts to complete their proceedings in medico legal cases.
