I am directed to refer to this Administration's circular letter 34/55-IH(7)-2009/13073 dated 07.07.2009 (copy enclosed) vide which the criteria for classification of posts as contained in the Punjab Civil Services (Revised Pay) Rules, 2009 was issued with immediate effect whereas the above rules have been made applicable by the Govt. of Punjab w.e.f. 01.01.2006. It is, therefore, clarified that the word 'with immediate effect' inserted in the circular letter referred to above may be read as '**with effect from 01.01.2006**'.


I am directed to address you on the subject noted above and to state that in pursuance of the Chandigarh Administration, Finance Department (Accounts Branch) Notification bearing No. 7000/1/2-F&RO(7)-2009/4029, dated 11th June, 2009 and in terms of the Govt. of India, Ministry of Home Affairs, New Delhi Notification bearing No. 14012/2/88-CHD, dated 13.1.1992, the Administrator, Union Territory, Chandigarh is pleased to adopt the criteria for classification of posts as contained in the Punjab Civil Service (Revised Pay) Rules, 2009 issued vide Govt. of Punjab Notification No. 5/10/09-5FRI/207, dated 27.5.2009, as under, with immediate effect:-

| Group 'A' | Posts in Grade Pay of Rs. 5000 and above. |
| Group 'B' | Posts in Grade Pay of Rs. 3800 to Rs. 4800. |
| Group 'C' | Posts in Grade Pay of Rs. 1900 to Rs. 3600. |
| Group 'D' | Posts in Grade Pay of Rs. 1300 to Rs. 1650. |

2. You are requested to make the amendment in the recruitment rules to the above extent after obtaining the orders of the competent authority and bring these guidelines/instructions to the notice of all employees working under your control for information and necessary action.

3. In making amendment in the recruitment rules to the above extent, no concurrence of the Department of Personnel would be required.
