

It is requested to sensitize your staff regarding postal ballots for exercising their right to vote. Any public servant working under you and deployed on election duty in Chandigarh but registered as an elector in any constituency other than Chandigarh can cast his/her vote using postal ballot. For this the public servant will have to apply in form 12 with a copy of his EPIC and Election duty orders to RO Chandigarh Chandigarh/ Nodal Officer (EDC & ETBPS). A facilitation centre for this purpose will also be set up at the election training venue. RO will forward this request to the concerned RO who will issue postal ballot to the public servant. The public servant will send the postal ballot after marking his/ her vote as per procedure to his concerned RO so that it reaches before the start of counting of votes.
