I am directed to address you on the subject cited above and to state that this Department has decided to fill up 01 post of Senior Surgeon under Directorate of Health Services [Level 11 in Pay Matrix(pre-revised Pay Band 3 - Rs. 15600-39100 + Rs. 6600/- Grade Pay)] under Directorate of Health Services by transfer on deputation basis from the Officers under the Central/State Governments/Union Territories.

As per Recruitment Rules for the above post, Officers of the Central/State Governments/Union Territories holding analogous posts on regular basis or with 5 years regular service in the post in the scale of Level 10 in Pay Matrix (pre-revised Pay Band 3 - Rs. 15600-39100 + 5400 Grade Pay) or equivalent and possessing the following educational Qualification and experience prescribed are eligible for the appointment by transfer on deputation:

i) Essential :

A recognized Medical Qualification included in the First or second Schedule or Part II of the Third Schedule (other than Licentiate qualification) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions stipulated in Sub-section (3) of section 13 of the said Indian Medical Council Act, 1956.

ii) Post-graduate degree, failing which post-graduate diploma in the speciality concerned.

iii) Work in a responsible position connected with the speciality concerned for 3 years after post-graduation Degree or five years after post-graduation Diploma.

iv) Knowledge of Konkani.

Note: In case of non-availability of a suitable candidate with the knowledge of Konkani, this requirement can be relaxed.

v) Desirable:

Knowledge of Marathi.

The period of deputation shall ordinarily not exceed 3 years and the pay and allowances of deputation will be fixed as per the existing rules of the Government.
