No. G.S.R. 21/Const./Art.309 and 318 read with 187/Amd.(7)/2019.-In exercise of the powers conferred by the proviso to article 309 and clause (b) of article 318 read with clause (3) of article 187 of the Constitution of India and all other powers enabling him in this behalf, the Governor of Punjab, after consultation with the Speaker of the Punjab Vidhan Sabha, in so far as such consultation is necessary under the aforesaid provisions, is pleased to make the following rules to further amend the Punjab Civil Services (Punishment and Appeal) Rules, 1970, namely:-

RULES .

1. (1) These rules may be called the Punjab Civil Services (Punishment and Appeal) First Amendment Rules, 2019.

(2) They shall come into force on and with effect from the date of their publication in the Official Gazette.

2. In the Punjab Civil Services (Punishment and Appeal) Rules, 1970, in rule 5, in clause (ix), for the words and sign "under the Government." the words and sign "under the Government:" shall be substituted and thereafter the following proviso shall be inserted, namely:-

"Provided that in a case in which the charge of possession of assets disproportionate to the known sources of income or the charge of acceptance from any person of any form of illegal gratification other than lawful remuneration as a reward for doing or forbearing to do any official act is established, the penalty mentioned in clause (viii) or clause (ix), shall be imposed:

Provided further that in any exceptional case, for reasons recorded in writing, any other penalty may be imposed."
