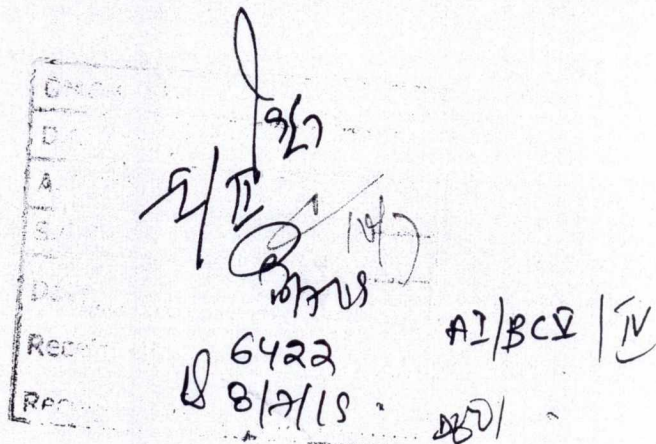

**Subject: - Regarding compliance of instructions issued on GeM.**

I am directed to refer this office letter No. 19/C2/2018/PEO(GeM)/1003 dated 25.09.2018, letter No 19/C2/2018/PEO(GeM)/1181 dated 14.11.2018 and 19/C2/2018/PEO(GeM)/1219 dated 28.11.2018 (copies enclosed) on subject cited above.

It is intimated that the Chandigarh Administration has issued instructions from time to time to ensure timely payment to GeM within the ten days from the date of generation of CRAC. However, it has been observed that most of the departments are not complying with the instructions as huge outstanding dues are reflecting on GeM portal. Besides, all Boards/Corporations were also requested to open and operate GeM pool Account authorized by GeM. The Non Government organization under Chandigarh Administration, which are yet to register themselves as GeM buyer must take necessary action for their registration under intimation to this office. But a few Boards/Corporations have not implemented the GeM pool Account even after repeated instructions.

It is therefore, again requested to follow the guidelines meticulously issued by Government of India circulated by this office pertaining to GeM. The copies of instructions are hereby enclosed ~~one~~ again.
