Regarding disbursement of pensionary benefits in respect of Old Pension Scheme.

Super Sa Madam

I am directed to invite your attention to the instructions issued by the Department of Finance, vide its letter No. 3/50/2017-3FPPC/1374237/1 dated 14.12.2018 whereby a new procedure with regard to the release of pensionary benefits was laid out.

The issue has been reconsidered by the Department of Finance in consultation with Accountant General (A&E). Punjab and it has now been decided to withdraw the above mentioned instructions issued vide No. 3/50/2017-3FPPC/1374237/1 dated 14.12.2018 with immediate effect, i.e. henceforth all cases of pension including revision of pension in respect of pensioners of Government of Punjab shall be authorized at the level of Accountant General (A&E), Punjab.

- Therefore, all cases in which revised pensionary benefits are admissible on any account are required to be sent by the Pension Sanction Authority to the Accountant General (A&E), Punjab for necessary authorization (as per the procedure laid down in relevant rules of Punjab Civil Services Rules Volume II). It is again reiterated, to remove all doubts, that the Pension Sanctioning Authority shall not sanction any revision of pensionary benefits at their own level.
- 4. However, the payment of Death Cum Retirement Gratuity (DCRG) shall be made by the Treasury/Bank as in the cases of pension and commutation of pension to curtail the delays. In case, any recoverable government due from the employee comes to the notice of government after the submission of the pension case to the Accountant General, Punjab,

the same shall be affected from the leave encashment payable to the pensioner at the level of Pension Sanctioning Authority.

5. Meticulous compliance of these instructions may kindly be ensured.
