In supersession of the order bearing Endst. No. A-2/2013/7486 dated 01.11.2013 issued by the Secretary Engineering, Chandigarh Administration and in pursuance of the instructions issued by the Department of Personnel, Chandigarh Administration vide circular letter No. 34/55-IH(7)-2013/13967 dated 31.07.2013, the Administrator, Union Territory, Chandigarh is pleased to allow extension in service for a period of one year to Sh. S.K. Chadha, Chief Engineer, Union Territory, Chandigarh beyond the age of superannuation from 31.12.2013 onwards subject to the following terms and conditions:-

1. That the option once exercised shall be considered as final and it shall not be allowed to be changed.
2. That the officer is entitled to pay equal to the pay last drawn by him on the date on which he attains the age of 58 years and the officer shall be entitled to the allowances applicable to him from time to time as per the rules.
3. That this order shall be applicable upto 31.12.2014 which has been computed from the date of superannuation or till the final decision in this regard is taken by the Chandigarh Administration or whichever is earlier.
4. That the officer shall not be entitled for any pensionary benefits during the said extension period.
