



As you might be aware, Right to Service Act has become operational in the UT of Chandigarh. Details in this regard may be seen on the Chandigarh Right to Service Commission's website: rtsc.chd.gov.in

2. In this regard, I am to inform you that in the first phase of its operation, the public services being rendered by only 05 departments (viz. (i) D.C. Office (ii) Estate Office (iii) Chandigarh Housing Board (iv) Municipal Corporation (v) Registering & Licensing Authority) have so far been notified vide No. 28/67/1-IH(11)-2019/ 14032 dated 13.09.2019 by the Administrator, UT Chandigarh

3. Now, in the second phase, public services of all the remaining departments/ boards/ corporations/ autonomous bodies etc. are to be notified in the official gazette; this is required as per Section 3 of the Act.

4. It is therefore requested that a list of all the Public Services being provided by your department to the people of the UT Chandigarh may kindly be sent to the Commission, in the prescribed format (Annexure 'A') as early as possible, and in any case, latest by 31st January, 2020

5. In case, nature of functions of a department is such that it is not providing any services to the general public, the requisite information may be sent as 'NIL'

6. The requisite lists may be sent both by post at the above given address and at email id: chd.rtsc@chd.nic.in
