I am directed to refer to this department's letters No. 2148-IH(7 2000/15464 dated 03.08.2000, No. 5664-IH(7)-2003/8744 dated 08.05.2003, No. 28/45-IH(7)-2015/11147 dated 02.06.2015 whereby provision are made for grant o honorarium to the Inquiry Officers and to state that it has been decided to chance the payment of honorarium to be paid to Inquiry Officers for conducting departmental inquires on Punjab pattern from Rs. 8000 to Rs.10,000/- and Rs. 1500/- for every additional charged officer in an inquiry subject to the condition that amount of honorarium shall not exceed Rs. 15,000/- in an inquiry.
