No.HIII(2)-2013/ 21928 In exercise of the powers conferred by Section 357 A of the Code of Criminal Procedure, 1973 (Act 2 of 1974) and in view of the directions contained in the Order dated 18.7.2013 of the Hon'ble Supreme Court of India passed in Writ Petition (Crl.) No.129 of 2006 titled Laxmi Vs. UOI and Others, the Administrator of the Union Territory of Chandigarh, is pleased to amend the Union Territory of Chandigarh Victim Assistance Scheme, 2012, namely:-

- 1. This scheme may be called the Union Territory of Chandigarh Victim Assistance (Amendment) Scheme, 2013.
- 2. It shall come into force on the day of its publication in the Official Gazette of Union Territory of Chandigarh Administration.
- 3. In clause 5 of the Union Territory of Chandigarh Victim Assistance Scheme, 2012 (hereinafter referred to as said Scheme), under the heading "Procedure for grant of assistance", at the end sub clause (iv) is added as under:-

In the cases of victims of acid attack, the amount of compensation as enumerated in Schedule 1 at Sr. No.10 annexed with the aforesaid scheme, a sum of Rs.1.00 lac shall be paid to the victims within 15 days of occurrence of such incident (or being brought to the notice of the State Government/Union Territory) to facilitate immediate medical attention and expenses in this regard. The balance sum of Rs. 2 lakhs shall be paid as expeditiously as may be possible and positively within two months thereafter.

4. In Schedule-I at Sr. No.10 of the said Scheme, the following shall be substituted as under:-
