He will continue to function as Director Cultural Affairs as an additional charge.

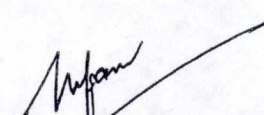
(b) Sh. Rajiv Tewari, AC (F&A), Chandigarh Housing Board
