I would like to draw your attention to an extremely important issue, i.e. revision of the Pension Payment Order (PPOs) of pensioners/family pensioners. This falls into two categories - (a) revision of PPOs of pre - 2006 (post-1990), and (b) revision of PPOs of pre-1990. The revision has to be done on priority because the pensioners are feeling harassed.

This department has been receiving a number of representations from individuals and Associations of Pensioners that their PPOs are not being revised. The matter was also discussed in the Standing Committee of Voluntary Agencies (SCOVA) meeting held under the chairmanship of Minister of State (PP) on 27.09.2012.

As per the information made available by the Central Pension Accounting Office (CPAO), the number of pre-1990 and pre-2005 PPOs pertaining to your Administration is 117 and 7403 respectively (copy enclosed).

I understand that the Government had been facing a lot of difficulties in getting relevant information from the banks in this connection. We have decided that the e-scroll of pensioners/family pensioners available with banks may be made good use of in retrieving information necessary for revision of PPOs. CPAO has revised the Life Certificate to get the information on address and telephone number of the pensioner. I hope that with these changes, PPOs in most of the cases can be revised. In case there is shortage of manpower, I would urge you to allow engagement of additional hands on contract basis, wherever feasible.

I would also request you to review the pending cases in your monthly or weekly 5 meetings, as the case may be, so that the pendency is reduced to zero. wetterwarmeagards

I am to bring to your kind notice that 202 DCRG cases upto 30/09/2012 in respect of UT Administration retirees are lying pending in this office. Most of the cases are pending due to (i) pending disciplinary cases or (ii) Court cases or (iii) LPC and NDC more for any mainly due to non vacation of Govt. accommodation.

Some of the cases are very old and need immediate settlement. Response of the concerned department in furnishing wanted documents is not satisfactory. Department wise list of pension case is enclosed for perusal. The rule position under CSR Vol-II of Punjab Civil Services Rules is very clear with regard to all such cases. All the Govt. dues including for the Govt. Accommodation allotted to the employees, have to be ascertained by the Pension Sanctioning Authority before sanctioning the pension and sending the case to this office for authorization. Recovery of the dues so ascertained upto the date of retirement is to be made from the sums payable to him up the date of his retirement. Recovery of Rent beyond the date of retirement is an arrangement between the Estate Manager/DDO and the retiring employees and withholding of DCRG on this ground i.e. NDC beyond the date of retirement is not borne out by any provision of rules.

I shall be grateful, if you kindly look into the matter personally and issue instructions to all the Controlling Officers/DDOs under Chandigarh Administration that all the cases before sending to this office, may be examined in the light of provisions of Rule 6.30, **9.16** and 9.17 of Punjab CSR Vol.-II so that any pendency in future may be avoided and the documents required in the cases pending may also kindly be sent urgently for their clearance.

In the event of failure of concerned offices to furnish the NDCs in the pending cases upto 31/03/2013, our office shall be constrained to authorize the withheld amount of DCRG on the administrative responsibility of the department concerned in view of the fact the indefinite withholding of DCRG cannot be justified under any statutory rule or provisions. Reply in this regard also shall be highly appreciable and awaited in our office.
