E-Auction Notice

The terms and conditions of e-Auction and for lifting of the condemned materials/items are as under:-

1. An auction of the following condemned material of MHI consisting of:-
(a) One lot consisting of Iron/Steel/Plastic/Linen **(As is where is basis)**
2. The Bids shall be in two Bid System i.e. Technical Bid and e-Auction Bid.
3. The Bidder must submit the following in physical mode upto **2:00 PM** on or before **20.05.2025**:-
 - GST No.
 - PAN
 - Affidavit regarding Non Black Listing by any Govt. As per Annexure "A".
4. The technical bid containing the above documents should reach this office physically by **20.05.2025 upto 2:00 PM**.
5. The rates quoted for condemned materials/items will be in Indian Rupees **(As is where is basis)**.
6. The successful bidder shall bear all expenses such as carriage charges, loading-unloading and shifting charges etc and have dismantle and lift the condemned materials/items within 7 days from the issue of sale order.
7. The successful bidder will be required to deposit 25% of the total tentative sale value within 24 hours after the issue of sale order alongwith Taxes and balance 75% will have to deposit immediately after actual weight of materials/items done.
8. TCS & GST will be charged extra as applicable.
9. The successful bidder shall make the payment in the D.D.O. A/c No. **36810963918 (IFSC Code SBIN0010607)** of the department through on-line or in the shape of Banker Cheque/Demand Draft (in favour of the Director MHI-32, Chandigarh) for the condemned materials/items on the basis of its actual weight done on the weighing machine.
10. In case the selected bidder does not show interest in depositing the balance sale value or in lifting the goods, within stipulated period (7days), the entire amount shall be forfeited and other actions initiated including resale of the goods in question at the risk and cost of the defaulter.
11. The items shall remain, in every aspect, at the risk of the buyer from the time of acceptance of his offer. The seller will not undertake any liability whatsoever for the safe custody, protection or preservation after the sale has been confirmed.
12. The decision of the Director MHI will be final and the Director, MHI reserves the right to accept/reject any bid (including highest bid) without assigning any reason thereof.
13. All disputes will be subject to Chandigarh jurisdictions.
14. E-Auction without digital signatures will not be accepted by the Electronic Tendering System.
