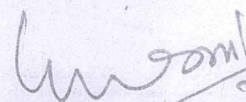
ORDERS

Whereas, a letter of intent for licencing out the Chemist Shop, New Emergency Trauma Centre, GMCH, Sector-32, Chandigarh was issued vide letter No. GMCH-Estate-III/2025/28981 dated 20.08.2025 and subsequent reminder vide No. 31381 dated 08.09.2025 to Sh. Arun Kumar Goyal S/o Sh. Surinder Kumar Goyal, H.No. MIG 2097, Ground Floor, Sector-66, SAS Nagar Mohali (Punjab), i.e. M/s. Chief Medicos, Booth No. 121-122, Sector-66, SAS Nagar, Mohali (Pb.) the H1 bidder. The bidder was requested to complete the requisite formalities within 10 days and 05 days more by issuing reminder for taking over the possession of the shop. In response to which the said bidder denied to accept the Letter of Intent vide his letter/e-mail dated 15.09.2025.

And whereas, Sh. Arun Kumar Goyal S/o Sh. Surinder Kumar Goyal, H.No. MIG 2097, Ground Floor, Sector-66, SAS Nagar Mohali (Punjab), has not completed the requisite formalities/submitted the requisite documents and denied to accept the letter of Intent. Accordingly, letter of Intent issued vide letter No. GMCH-Estate-III/2025/28981 dated 20.08.2025 and subsequent reminder vide No. 31381 dated 08.09.2025 to Sh. Arun Kumar Goyal S/o Sh. Surinder Kumar Goyal were cancelled and the earnest money amounting to Rs.93,000/- (Rupees Ninety Three Thousand only) in the shape of EMD bearing No. 845388 dated 29.07.2025 of the Punjab National Bank, Industrial Area, Phase-II, Chandigarh was forfeited as per clause No. 5 of the tender/e-bid document under instructions/Guidelines.

Since, Sh. Arun Kumar Goyal S/o Sh. Surinder Kumar Goyal failed to complete the mandatory formalities resulting into loss of revenue to Govt. exchequer which also tantamount to subtraction of government facilities to the patient as well as their attendants. Therefore, Sh. Arun Kumar Goyal S/o Sh. Surinder Kumar Goyal, H.No. MIG 2097, Ground Floor, Sector-66, SAS Nagar Mohali (Punjab) i.e. M/s. Chief Medicos, Booth No. 121-122; Sector-66, SAS Nagar, Mohali (Pb.) is hereby blacklisted as per Clause No. 18 under instructions & guidelines of tender/e-bid document for a period of five (05) years.

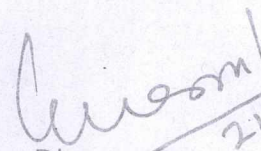
