(Griggs without forceps) 11.06.2019

- Should have scalpel with number 10 blade
- Should have an introducer needle
- Should have a 10ml syringe for aspiration
- Should have a 14Fr pre-dilator
- Should have extra long guide wire
- Should have a cuffed tracheostomy tube introducer
- Should have swabs for cleaning
- Should have a tracheostomy tube holder
- Should have CE/BIS/USFDA approval
