1. The Bids shall be in two Bid System i.e. Technical Bid and e-Auction Bid.
2. The Technical Bid should contain:-
  - EMD of Rs.5000/-, Rs.5000/- & Rs.5000/- for Sr.No.1,2 & 3 respectively payable in favour of the Director Principal, Govt. Medical College Hospital, Sector 32, Chandigarh in the shape of Banker Cheque/Demand Draft.
  - GST No.
  - PAN
  - Affidavit regarding Non Black Listing by any Govt. As per Annexure "A".
3. The technical bid containing the above documents should reach this office physically by 19/08/2019 upto 2:00 P.M
4. Bidders having PAN number are only eligible to participate in the bid.
5. The rates quoted for condemned vehicles will be in Indian Rupees on As is where is Basis.
6. The successful bidder shall bear all expenses such as carriage charges, loading-unloading and shifting charges etc and have dismantle and lift the condemned vehicles within 7 days from the issue of sale order.
7. The successful bidder will be required to deposit 25% of the total tentative sale value within 12 hours after the issue of sale order alongwith Taxes and balance 75% will have to before lifting the vehicle.
8. The successful bidder shall make the payment in the **D.D.O. A/c No. 10413584255 (IFSC CodeSBIN0010607)** of the department through on-line or in the shape of Banker Cheque/Demand Draft for the condemned vehicles.
9. In case the selected bidder do not show interest in depositing the balance sale value or in lifting the goods, the bid security should be forfeited and other actions initiated including resale of the goods in question at the risk and cost of the defaulter.
10. In case the vehicle is not lifted/removed from the auction site within 7 days from the date of auction the entire amount deposited will be forfeited.
11. The vehicle shall remain, in every aspect, at the risk of the buyer from the time of acceptance of his offer. The seller will not undertake any liability whatsoever for the safe custody, protection or preservation after the sale has been confirmed.
12. In the event of highest bidder fails to lift the vehicle the second highest bidder will be considered and accordingly third bidder will may also be considered at the bid given by the highest bidder.
13. The EMD of the unsuccessful bidders will be returned after finalization of the E-Auction process.
14. The decision of the Director Principal of GMCH will be final and the Director Principal GMCH reserves the right to accept/reject any bid (including highest bid) without assigning any reason thereof.
15. All disputes will be subject to Chandigarh jurisdictions.
16. E-Auction without digital signatures will not be accepted by the Electronic Tendering System.
