This appointment is on the following conditions:

1. **Tenure of Post**

- (a) The appointment is purely on contract basis.
- (b) The offer of appointment is valid only till the regular incumbent made/join in GMCH through UPSC, New Delhi.
- (c) This appointment is provisional and is subject to the Caste/Tribe Certificates being verified through the proper channels (in case of reserve category) and if the verification reveals that the claim to belong to OBC Caste community, as the case may be, is false, the service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of false certificates.
- (d) The offer of contractual appointment is made initially for a period of one year or till the posts are filled up on regular basis whichever is earlier.
- (e) This contractual appointment can be terminated at any time with one month's notice from either side i.e. the appointee or the appointing authority, without assigning any reason whatsoever. It will be open to the Administration to pay, in lieu of notice, emoluments/remuneration for the period by which the notice falls short of one month. Similarly, if he/she wish to resign his/her post he/she may do so by depositing the emoluments/remuneration in lieu of the notice period by which it falls short of one month at the time of submission of his/her resignation notice; failing which an interest @ 18% p.a. will be charged with effect from the date of submission of his/her resignation.
- (f) The contract appointment will, however, be terminable by the Government without previous notice in case: -
 - i. If, it is satisfied on medical evidence that he/she is unfit and is likely to continue unfit for a considerable period for reasons of ill health and unable to discharge his/her duties; provided that the decision of the Government that he/she is likely to continue unfit, shall be final and binding on him/her.
 - ii. If it is satisfied on verification that his/her character and antecedents are such that he/she is not fit for being retained in Government service.
 - iii. If the fact that any of the declaration made or information furnished or that there has been suppression of any factual information in the Attestation Form comes to the notice at any time, during the service of a person, his/her services would be liable to be terminated and also such other action as the Government may deem necessary will be taken.
 - iv. If it is found that he/she has mis-conducted, his/her services would be terminated.

2. **Emoluments**

He/She will be paid the consolidated remuneration/emoluments from the Wage Head of this Institute as mentioned against each and as fixed by the Chandigarh Administration, which may be reviewed at the time of renewal of his/her contractual appointment, as per instructions issued by Chandigarh Administration from time to time in this regard.

3. Leave, C.P.F. & other Service Benefits

- i) One day's casual leave per month will be admissible with the approval of the Head of the Department. No other leave of any kind is admissible. However, in special circumstances, leave without pay will be granted solely at the discretion of the Head of the Department. Vacations as admissible will be allowed, if permissible under Rules.
- ii) No other benefit like Annual increments, Allowances, Contributory Provident Fund, Pension, Gratuity, Seniority, LTC etc. will be admissible.

4. Status of Post

The status of the post is Group 'A'.

5. Oath and Allegiance

On joining the post he/she will have to take an oath of allegiance to the constitution of India.

6. Marriage Certificate

This offer of appointment is subject to the condition that he/she will give declaration of his/her marital status. In case of married he/she should have only one living spouse.

7. General Terms & Conditions

- i) The offer of appointment is further subject to the compliance of the following terms & conditions:
- a) Production of the following certificates, in original, in proof of his/her academic qualifications and age.
- b) Degree certificates for educational & technical qualifications and experience etc.
- c) Date of birth certificate.
- d) Discharge/Relieving certificate from his/her present employer.
- ii) Private practice, of any kind, including laboratory and consultant practice, is strictly prohibited.
- iii) He/she is liable to serve in any of the Health Centers/Institutions of the Administration, if so required.
- iv) His/her application for post outside the Administration will not be forwarded till completion of the tenure of contractual appointment.
- v) He/she shall take full load of the work prescribed in the duties. In addition he/she will also be required to discharge the additional duties as and when assigned by the authorities.
- vi) The appointing authority reserves the right to assign him/her any duty as and when required. No extra/ additional allowance will be admissible in case of such assignments.
- vii) He/she will be on the whole time appointment and shall not accept any other appointment paid or otherwise/ private practice of any kind during the period of contract.
- viii) The contract appointment will not count as service and will not bestow upon his/her any claim or right for regular appointment against any post in this institute.
- ix) He/she will be allowed reimbursement of Indoor Medical Treatment in the Government/Government authorized hospitals/institutions subject to completion of all other formalities, as admissible under Central Govt. Rules.
- x) All disputes, if any, shall be decided by the Sole Arbitration by the Secretary, Medical Education & Research, Chandigarh Administration and his decision shall be final and binding upon him/her.
- xi) The other conditions of service will be governed by relevant rules and orders for contractual appointments issued from time to time by the Chandigarh Administration.


Note:

However, you are required to join your duties within one month from the date of issue of this appointment letter subject to fulfillment of the condition at clause 8 above. If you fail to report within the stipulated period, it will be presumed that you are not interested in offered appointment and the offer will stand automatically cancelled.

At the time of joining he/she is required to bring latest 05 passport size photographs, copy of PAN card, Aadhar Card, copy of bank passbook mentioning account details and relieving certificate from the present employer, if any, and an attested copy of Date of Birth Certificate. Acceptance of the offer may please be sent immediately, failing which he/she will not be allowed to join.


