

The written test paper will be of one hour duration (01) and shall consist of 50 questions of multiple choice types with single correct answer . The answer will be in the form of A, B, C or D. Each question will carry 01 mark. The question paper will only be in English medium. The questions will be based on subject contents as per advertisement.
