- 6. Appointment will be purely on contract basis (temporary in nature). The appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in GMCH 32 or continued contractual appointment. The PI has right to cancel the candidature at any time.
- 7. The appointed staff may have to work in the emergency situations, field visits and travel outstation.
