

Post Code should be exactly same, as mentioned in this advertisement for the post, candidate wish to apply for.No other mode of application will be accepted.
2. The candidates should send only the soft copy of duly filled application form **in the given format only**, along with one set photocopies of self-attested documents viz.(Academic Degrees/Certificates, Professional Degrees/Certificates, Experience, Aadhar Card, Caste Certificate (if applicable) through this email- **pathogmch@gmail.com** in a **single PDF file**. The applications not in the prescribed format will be summarily rejected.
3. The contractual appointment will be made initially for one year and extendable up to two years or till the completion of project.
4. Separate application forms should be submitted if a candidate wishes to apply for more than one post.
5. The recruited project staff are eligible for leave as per rules and will have to give an undertaking at the time of joining.
6. The interviews for the advertised posts will be conducted at Department of Pathology, Government Medical College and Hospital, Chandigarh and the date of which shall be intimated later via email to the shortlisted candidates only.
7. The conditions for employment will be same as that of the ICMR project staff on contract basis. Candidates working/have worked under project in ICMR institutes/centers will be given ‘One time’ age relaxation, as per the Institute rules and regulations.
8. Age, qualification, experience etc. will be reckoned as on the last date of submission of application form.
9. Hostel accommodation of any kind is not available with the Institute.
