
1. Post : **DATA ENTRY OPERATOR**

  2. 1-year Diploma course in computer application.
  3. Experience of minimum 1 year in Data management.

2. Post : **LABORATORY TECHNICIAN**  
Pay: Rs. 30,000/- per month consolidated  
Essential Qualification: Graduate in Medical Laboratory Technology from a recognized University/Institute/Hospital  
**OR**  
Diploma in Medical Laboratory Technology (MLT) with the course of at least 2 years duration from a recognized University.  
**OR**  
Diploma/Certificate in Medical Laboratory Technology (MLT) with the course of at least one year Duration from a recognized University.  
  
Desirable:
  - ❖ 1 year experience for those of working in medical laboratory with diploma in MLT (2 year course) from recognized Central Government/ State Government hospital/ Institute/ Autonomous / Private Institute.
  - ❖ 2 years' experience in working in medical laboratory for those with diploma in MLT (1 year course) from a recognized Central Government/Delhi Government hospital/ Institute/Autonomous/Private Institute.


